ECONOMIC UPDATE

Since our last update, Senate Majority Leader Mitch McConnell (R-KY) released the Senate GOP's Phase 3 package, the Coronavirus Aid, Relief, and Economic Security (CARES) Act (S. 3548). Leader McConnell then indicated he wants the Senate to pass the stimulus bill on Monday, March 23. However, in opening floor remarks today, Senate Minority Leader Chuck Schumer (D-NY) suggested the CARES Act is "inadequate" and "doesn't help hospitals." Nonetheless, bipartisan talks have been underway in the Senate today, and Leader McConnell tasked the teams to reach an agreement by midnight tonight.

The plan as of now is to move to a motion to proceed tonight on a shell. Then, the Senate will draft the final bill tomorrow, Saturday, March 21, in order to set up votes on Monday.

Reminder: Leader McConnell has suggested Phase 3 may not be the last package and continues to reiterate the Senate will not leave town until the third package is passed.

PUBLIC HEALTH UPDATE

Senate Majority Leader McConnell [introduced](#) the legislative text for the 247-page Phase 3 coronavirus aid proposal. The [Coronavirus Aid, Relief, and Economic Security \(CARES\) Act](#) would, among other things, suspend a 2% Medicare payment cut to providers until the end of 2020, provide \$1.32 billion in funding for community health centers, give hospitals a 15% Medicare payment for treating COVID-19 patients, and increase flexibility for telehealth services during the pandemic. Senate Republicans began negotiations on Phase 3 legislation with Democrats today. In addition to these congressional efforts, President Trump [triggered](#) the Defense Production Act to shore up production of medical supplies and devices.

Congressional

- Speaking on the Senate floor, Majority Leader McConnell [stated](#) he hopes to reach a bipartisan agreement on the CARES Act today, with passage out of the chamber on Monday. He also noted this will not be the last stimulus bill.
- Speaking on the Senate floor, Democratic Leader Schumer noted the Phase 3 coronavirus relief bill is inadequate and fails to provide assistance to hospitals. He stated, "...if we don't deal with the health crisis, nothing we do will make the economy any better." He added that he sent a white paper to Leader McConnell outlining Democratic demands for the CARES Act and that President Trump expressed support for these ideas in a conversation they had earlier today.
- Ways and Means Republicans released a [summary](#) of the Medicare and health tax portion of the CARES Act.
- Yesterday, House Speaker Pelosi and Senate Democratic Leader Schumer issued a [statement](#) in response to Senate Republicans Phase 3 legislation, indicating they are looking forward to working with Republicans "in a bipartisan way to deliver for the American people as soon as humanly possible."
- Yesterday, Senate HELP Committee Ranking Member Murray sent a [letter](#) to the HHS Inspector General asking for an investigation into the delays in development and deployment of coronavirus tests.
- Yesterday, the House Oversight and Reform Committee sent a [letter](#) to HHS Secretary Azar and CDC Director Redfield, requesting information about the status of coronavirus testing in the U.S.
- Yesterday, the Congressional Progressive Caucus sent a [letter](#) to Speaker Pelosi outlining 12 priorities for Phase 3 legislation.

Administration

- During a [briefing](#) of the coronavirus task force, President Trump stated he put the Defense Production Act "into gear" last night and that millions of masks will be shipped directly to states.
- In light of the orders to shelter in place in California and New York, NIAID Director Dr. Fauci and Vice President Pence implored Americans to heed their

local authorities, listen to their guidance, and follow recommendations to slow the spread.

- Dr. Fauci clarified that hydroxychloroquine is not considered potential therapy for people who have been infected with COVID-19. He noted information that it may be used as a prophylactic is anecdotal evidence. It was not done in a controlled clinical trial so no definitive statement can be made about it.
- During a briefing of the coronavirus task force, White House Coronavirus Response Coordinator Birx stated we are seeing a very concerning trend from Italy "that the mortality in males seems to be twice in every age group of females."
- The FDA issued a [new policy](#) allowing manufacturers of certain FDA-approved vital sign-measuring devices to expand their use so that healthcare providers can use them to monitor patients remotely.
- The FDA issued [guidance](#) to help meet the demand for alcohol-based hand sanitizer during the COVID-19 outbreak.
- Yesterday, CMS [approved](#) a Section 1135 waiver request for the state of Washington. This waiver authority will grant Washington's state government more flexibility to respond to the outbreak.
- Yesterday, HHS Secretary Azar held a [teleconference](#) with his counterparts from G7 countries to share information and measures each country is taking to combat the coronavirus outbreak.
