



DAILY COVID-19 UPDATE

April 1, 2020

WHAT HAPPENED TODAY

This morning, senior House Democrats held a press conference to further discuss their priorities as they relate to a Phase IV coronavirus aid bill and rebuilding the nation's infrastructure program. The [plan](#), as outlined by Speaker Pelosi, would include funding for community health centers, expanded broadband access, improvements to drinking water systems, and upgrades to public transit, roads, and bridges, among other items. Speaker Pelosi stated she is "pleased the President has returned to his interest" in the issue, and suggested an infrastructure proposal is "essential because of the historic nature of the health and economic emergency that we are confronting."

ECONOMIC UPDATE

Congressional

- **House**
 - This morning, Speaker Pelosi held a press conference regarding critical infrastructure investments to overcome coronavirus and support economic recovery. She acknowledged House Democrats are building on their [Moving Forward infrastructure framework](#), introduced in January 2020, to include funding for community health centers, clean water, broadband, and mobility.
- **Senate**
 - Banking Committee Ranking Member Sherrod Brown (D-OH), Finance Committee Ranking Member Ron Wyden (D-OR) and Senate Democratic

Leader Chuck Schumer (D-NY) yesterday [sent a letter](#) to Secretary Mnuchin and called on him to provide Congress with a plan and timeline for the Special Inspector General for Pandemic Recovery's (SIGPR) creation and implementation.

- The Senate Finance Committee [updated its FAQ](#) on the CARES Act: Employee Retention Credit.
- The Senate Republican Policy Committee (RPC) [published a compilation](#) of Senate committee materials on the CARES Act.
- Banking Committee Ranking Member Sherrod Brown (D-OH) today (April 1) [released a statement](#) as rent and mortgage payments are due for millions of households whose jobs have been affected by the coronavirus. Ranking Member Brown plans to introduce legislation to help homeowners and renters during the COVID-19 pandemic.

Administration

- Treasury
 - The Treasury Department and the IRS [released FAQs](#) to help small- and mid-sized businesses navigate paid sick and family leave tax credits.
- Internal Revenue Service (IRS)
 - The IRS [published a notice](#) to provide penalty relief with respect to certain employers' deposits of Federal employment taxes.
 - The IRS [published an FAQ](#) on the Employee Retention Credit under the CARES Act.

PUBLIC HEALTH UPDATE

Congressional

- **House**
 - Reps. Kuster and McBeth [introduced](#) legislation to help consumers fill prescriptions during emergencies.
 - Rep. Rose [introduced](#) new legislation to provide critical relief for medical providers who have been gravely impacted by the ongoing coronavirus pandemic. H.R. 6426 would establish a program to provide very low-interest loans to healthcare organizations to assist them with anticipated revenue loss or higher operating costs as a result of COVID-19.
 - Rep. Thompson, Chairman of the Committee on Homeland Security, released [legislation](#) he will be introducing in the coming days to establish an independent, bipartisan, Congressionally-chartered commission to produce a

full and complete accounting of the nation's preparedness and response to COVID-19.

- Rep. Walden [praised](#) recent action by the Federal Communications Commission (FCC) to lower barriers for providing care to rural communities during COVID-19.
- Rep. Walden [penned](#) an op-ed on the *CARES Act* in The Hill.
- Rep. Schneider sent a [letter](#) to Speaker Pelosi and House Energy & Commerce Chairman Pallone urging the creation of a singular emergency COVID-19 medical supply chain authority, or "supply chain czar," with statutory authority to oversee the acquisition and distribution of ventilators, PPE, and other supplies.
- **Senate**
 - Sen. Coons [called for](#) the U.S. to update and expand domestic vaccine manufacturing capacity to respond to COVID-19 and future pandemics.
 - Sen. Brown [spoke out](#) against the Trump Administration for refusing to reopen enrollment for the ACA's federal exchanges amid the coronavirus pandemic.
 - Sen. Brown [called for](#) pandemic pay and health protections for all frontline workers during the COVID-19 outbreak.
 - The Senate Republican Policy Committee (RPC) posted a [compilation](#) of Senate committee materials on the CARES Act.

Administration

- Centers for Medicare & Medicaid Services
 - CMS [approved](#) four additional Medicaid Section 1135 waiver requests to give states flexibility to address the coronavirus pandemic, bringing the total number of approved waivers to 38.
- Centers for Disease Control and Prevention
 - New [data](#) released by the CDC shows that people who have chronic medical conditions, such as diabetes, lung disease and heart disease, face an increased chance of being hospitalized with COVID-19 and put into intensive care.
- Food and Drug Administration
 - FDA [initiated](#) a new program, the Coronavirus Treatment Acceleration Program (CTAP) to expedite the development of potentially safe and effective life-saving treatments.
 - FDA posted information regarding shortages of hydroxychloroquine and chloroquine to its drug shortage [webpage](#) due to a surge in demand. The agency [reported](#) it is working with manufacturers to evaluate supply and market demand for patients dependent on these drugs for treatment of malaria, lupus and rheumatoid arthritis.

LABOR UPDATE

Regulatory/Implementation Guidance

- The Department of Labor
 - DOL announced [new action](#) regarding how American workers and employers will benefit from the protections and relief offered by the Emergency Paid Sick Leave Act and Emergency Family and Medical Leave Expansion Act, both part of the Families First Coronavirus Response Act (FFCRA). The department's Wage and Hour Division (WHD) posted a [temporary rule](#) issuing regulations pursuant to this new law, effective today, April 1, 2020.

SUPPLY CHAIN/CRITICAL INFRASTRUCTURE UPDATE

Congressional

- House Homeland Security Committee Democrats [announced](#) they will introduce the COVID-19 Commission Act, which would establish a bipartisan commission to investigate the circumstances surrounding the emergence of the virus and identify lessons learned regarding preparedness, response, and recovery nationwide. The Commission would include individuals with expertise in emergency preparedness, supply chain and logistics, and election security. ([fact sheet](#), [bill text](#))
