



## DAILY COVID-19 UPDATE

April 17, 2020

### WHAT HAPPENED TODAY

While the PPP negotiations seem to be at a standstill, House Minority Leader McCarthy's [comments](#) in support of a Democratic proposal to add additional hospital funding to a \$250 billion relief package for small businesses could be an early sign of a deal coming together.

During yesterday's daily press conference, President Trump unveiled an 18-page, three-phase plan outlining guidelines for "[Opening Up America Again](#)", which defers to governors on when and how to ease their social distancing protocols.

Notably, the distribution of the second tranche of the \$100 billion emergency fund for hospitals appears to be on hold. Yesterday, HHS Secretary Azar told House Democrats it would take another week and a half to calculate how the funds will be distributed.

Since our last update, the Food and Drug Administration, the Department of Labor, and the Cybersecurity and Infrastructure Security Agency published additional guidance. Please see below for more details.

### ECONOMIC UPDATE

- Congressional*  
• *House*

- Yesterday, Financial Services Committee Chairwoman Maxine Waters (D-CA) sent a [letter](#) to Jerome Powell, Chair of the Board of Governors of the Federal Reserve System, urging him to address concerns regarding the implementation of programs and facilities authorized by the CARES Act.
- Ways and Means Republicans [posted](#) the Wall Street Journal Editorial Board's piece entitled, "No More Paycheck Protection" on its Coronavirus Bulletin page.
- **Senate**
  - Banking Committee Chairman Mike Crapo (R-ID) [sent two letters](#) to the U.S. Department of Treasury and Federal Reserve Board of Governors today on provisions under Title IV of the CARES Act. The [first letter](#) highlights the Committee's robust oversight role over Title IV of the CARES Act. The [second letter](#) urges action on several issues with respect to 13(3) emergency lending facilities announced recently, including the Paycheck Protection Program (PPP) Loan Facility, Main Street Lending Facilities, TALF, Primary and Secondary Market Corporate Credit Facilities and the Municipal Lending Facility.
  - Banking Committee Ranking Member Sherrod Brown (D-OH), Senator Kamala Harris (D-CA), and Reps. Ayanna Pressley (D-MA) and Gregory Meeks (D-NY) yesterday [led](#) Democratic lawmakers in calling for the Small Business Administration (SBA) and Treasury Department to ensure that minority-owned businesses are not shut out of the Paycheck Protection Program (PPP).
  - The Senate Democratic Caucus sent a [letter](#) to Majority Leader Mitch McConnell (R-KY) and Treasury Secretary Steven Mnuchin to allow state and local governments to use stabilization funds to fix state budget shortfalls. Currently, funds can only be used to reimburse for COVID-19 related expenses.
  - Banking Committee Ranking Member Sherrod Brown (D-OH) and Senator Cory Booker (D-NJ) today [urged](#) more than a dozen bank CEOs to temporarily ban charging customers burdensome bank overdraft fees during the coronavirus emergency.

## **PUBLIC HEALTH UPDATE**

#### ***Congressional***

- Reps. Pallone and Maloney as well as Sen. Murray sent a [letter](#) to HHS Secretary Azar urging the Department to lift its restrictions on fetal tissue use when it comes to federally supported research related to the coronavirus.
- House**
  - The Office of Speaker Pelosi released a [document](#) titled, "Talking Points: Democrats Work to Provide Emergency Relief for Underserved Small Businesses in Rural and Urban Communities Across America."
  - Rep. DeLauro wrote in a [letter](#) to HHS Secretary Azar that the second wave of emergency funding for hospitals is on hold after CMS Administrator Verma suggested it would be distributed this week.
  - Reps. Wenstrup, Kind, Kelly, and Schneider sent a [letter](#) to HHS Secretary Azar and CMS Administrator Verma regarding lower Medicare accelerated and advance payment interest rates.
  - Rep. Arrington penned an [op-ed](#) in the Washington Examiner titled, "We must also flatten the curve of rural hospital closures."
- Senate**
  - Sen. Durbin led eight Democratic senators in a [letter](#) to HHS Secretary Azar urging the Department to alter the formula for the next round of hospital funding.

- Sen. Lankford led 25 senators in a [letter](#) to HHS Secretary regarding Public Health and Social Services Emergency Fund support for nursing homes and skilled nursing centers.

### **Administration**

- White House
  - President Donald J. Trump announced [guidelines](#) for opening up America again.
  - The White House released a [fact sheet](#) titled, "President Donald J. Trump Is Beginning the Next Phase In Our Fight Against Coronavirus: Guidelines for Opening Up America Again."
- Health and Human Services
  - HHS Secretary Azar issued a [statement](#) on NIH's new public-private partnership to develop a national strategy for COVID-19 therapies and vaccines.
- Food and Drug Administration
  - FDA [announced](#) a further expansion of COVID-19 testing options through the recognition that spun synthetic swabs – with a design similar to Q-tips – could be used to test patients by collecting a sample from the front of the nose. As part of this effort, UnitedHealth Group, Quantigen, and the Gates Foundation will be collaborating to perform and support the clinical studies necessary for this advancement. Additionally, U.S. Cotton will be manufacturing a new type of swab for COVID-19 testing that can be produced at scale.
  - FDA launched a [new webpage](#) to guide recovered COVID-19 patients to local blood or plasma collection centers to discuss their eligibility and potentially schedule an appointment to donate.
  - FDA issued a [guidance](#) for immediate implementation setting forth a temporary policy for outsourcing facilities to compound certain human drugs for hospitalized patients during the COVID-19 public health emergency. This guidance is being issued to provide patient access to treatment options for COVID-19 when hospitals experience difficulties accessing certain FDA-approved drugs.
  - FDA issued [guidance](#) to help expand the availability of telethermographic systems used for body temperature measurements for triage use for the duration of the public health emergency.
  - FDA added [content](#) to the question-and-answer appendix in its guidance titled "Conduct of Clinical Trials of Medical Products during COVID-19 Public Health Emergency."
  - FDA posted [tips](#) on [Shopping for Food During the COVID-19 Pandemic - Information for Consumers](#) and a downloadable [PDF](#). These materials reassure consumers that there is currently no evidence of human or animal food or food packaging being associated with transmission of the coronavirus that causes COVID-19.
- National Institutes of Health
  - NIH and the Foundation for NIH [announced](#) plans underway to launch a public-private partnership, known as the Accelerating COVID-19 Therapeutic Interventions and Vaccines (ACTIV) partnership, with more than a dozen biopharmaceutical companies, HHS's Biomedical Advanced Research and

Development Authority, the Centers for Disease Control and Prevention, the Food and Drug Administration, and the European Medicines Agency, to develop a national strategy for a coordinated research response to the COVID-19 pandemic.
