



## DAILY COVID-19 UPDATE

June 1, 2020

### WHAT HAPPENED TODAY

Today, in opening floor remarks, Senate Majority Leader Mitch McConnell (R-KY) stated he expects the Senate will soon pass [H.R. 7010](#), the *Paycheck Protection Flexibility Act*, which was advanced by the House last week. The bipartisan bill modifies the Paycheck Protection Program (PPP) to extend the window small businesses have to use funds from eight weeks to 24 weeks, and allow businesses to repay loans over a five-year period instead of two years.

Additionally, Rep. Kevin Brady (R-TX) introduced [legislation](#) that would create a "return to work bonus." Under the proposal, workers would receive a payment of \$1200, the equivalent of two weeks of unemployment benefits, if they accept a job offer. The boosted unemployment benefit of \$600 per week is set to expire on July 31.

Notably, lawmakers on both sides of the aisle have [expressed support](#) for expanding the employee retention tax credit (ERTC) established under the CARES Act. The House-passed *HEROES Act* contains a section that would expand the employee retention tax credit by increasing the amount of credit so that businesses could get a credit of 80% on up to \$15,000 of wages per employee each quarter. The provision would also allow employers to be eligible for both the credit and the PPP.

## ECONOMIC UPDATE

### Congressional

#### HOUSE:

- House Ways and Means Chairman Richard Neal (D-MA) [expressed support](#) for expanding the employee retention tax credit (ERTC).
- In a [tweet](#), Rep. Stephanie Murphy (D-FL) claimed expanding the employee retention tax credit “continues to gain meaningful bipartisan support.”
- Rep. Darin LaHood (R-IL) [introduced](#) a bill that would provide businesses with a temporary tax break for the costs of cleaning their locations.
- House Financial Services Committee Chairwoman Maxine Waters (D-CA) [released a statement](#) regarding the Treasury’s and Small Business Administration’s announcement to set aside \$10 billion in Paycheck Protection Program (PPP) funds for Community Development Financial Institutions (CDFIs).

#### SENATE:

- Senate Banking Committee Ranking Member Sherrod Brown (D-OH) [released a statement](#) on the resignation of Joseph Otting as the Comptroller of the Currency.
- Senator Bernie Sanders (I-VT) [urged](#) the Senate to pass further coronavirus aid legislation.

### Administration

#### FEDERAL RESERVE

- Federal Reserve Chairman Jerome Powell [announced](#) the Main Street Lending Program (MSLP) will soon begin purchasing loans.

#### OFFICE OF THE COMPTROLLER OF THE CURRENCY (OCC)

- Acting Comptroller of the Currency Brian P. Brooks [expressed concerns](#) about the effects of regional and local responses to COVID-19 on the federal banking system.

## PUBLIC HEALTH UPDATE

### Congressional

#### HOUSE:

- Reps. Larson and Courtney [announced](#) they will be introducing *the Pandemic Essential Supplies Act*. The Act will instruct the Defense Logistics Agency to lead the federal management, procurement and distribution of emergency supplies that are critical for our nation's COVID-19 response.
- Speaker Pelosi participated in an [interview](#) with ABC's This Week to discuss *The Heroes Act*.

#### SENATE:

- Sen. Alexander released a [statement](#) disagreeing with President Trump's decision to terminate the United States' membership in the World Health Organization (WHO).
- Sens. Hassan, Murray, and Sanders sent a [letter](#) to CDC Director Redfield regarding declining childhood immunization rates amid the coronavirus pandemic.
- Sen. Markey led a bipartisan group of 12 senators in a [letter](#) to Majority Leader McConnell and Minority Leader Schumer, urging them to prioritize medical research funding for Myalgic Encephalomyelitis/Chronic Fatigue Syndrome (ME/CFS) in any upcoming coronavirus relief package.

### Administration

#### THE WHITE HOUSE

- The White House announced the U.S. government has [delivered](#) 2 million doses of hydroxychloroquine (HCQ) to Brazil and will also be sending 1,000 ventilators to Brazil as well. Additionally, the White House announced a joint United States-Brazilian research effort that will include randomized controlled clinical trials further evaluating the safety and efficacy of HCQ for prophylaxis and the early treatment of COVID-19.

#### DEPARTMENT OF HEALTH AND HUMAN SERVICES

- As part of the Trump Administration's Operation Warp Speed, HHS [announced](#) a task order with Emergent BioSolutions to advance manufacturing capabilities and capacity for a potential COVID-19 vaccine as well as therapeutics. The task order is worth approximately \$628 million and falls under an existing contract with BARDA.

#### CENTERS FOR DISEASE CONTROL AND PREVENTION

## FOOD AND DRUG ADMINISTRATION

- FDA is making its previously developed FDA [MyStudies app](#) available to investigators as a free platform to securely obtain patients' informed consent for eligible clinical trials when face-to-face contact is not possible or practical due to COVID-19 control measures.
- The FDA [took steps](#) to further support the development of COVID-19 tests for at-home self-collection by providing on its website a template that may be used to facilitate submission of requests for emergency use authorizations (EUA) for at-home sample collection kits.
