WHAT HAPPENED TODAY

Today, President Trump signed [H.R. 7010](#), the *Paycheck Protection Program Flexibility Act* of 2020 into law.

Additionally, during a White House briefing, President Trump stated he will be asking Congress for "additional stimulus money," including a payroll tax cut, which he noted would be "a tremendous incentive for businesses" to hire more employees.

Notably, the Bureau of Labor Statistics released its monthly jobs report, which found the U.S. economy added 2.5 million jobs in May and the unemployment rate dropped to 13.3% as businesses began reopening after coronavirus-related closures.

Senate Majority Leader Mitch McConnell (R-KY) continues to say future coronavirus legislation "must be laser-focused on helping schools reopen safely in

the fall, helping American workers continue to get back on the job, and helping employers reopen and grow."

ECONOMIC UPDATE

Congressional

HOUSE:

- House Financial Services Committee Chairwoman Maxine Waters (D-CA) [issued a statement](#) regarding a letter that Acting Comptroller of the Currency Brian Brooks sent to the National League of Cities, the U.S. Conference of Mayors, and the National Association of Governors regarding efforts to combat COVID-19.
- Rep. Carolyn Maloney (D-NY) [released a statement](#) following a new report showing that overdraft fees costs consumers more than \$11 billion in 2019.

SENATE:

- Senate Majority Leader Mitch McConnell [issued](#) the following statement regarding the economy.
- Senate Finance Committee Chairman Chuck Grassley (R-IA) [sent a letter](#) to Internal Revenue Service Commissioner Charles Rettig in regard to noncompliance.

PUBLIC HEALTH UPDATE

Congressional

HOUSE:

- Reps. Kuster and Jeffries introduced the [Coronavirus Vaccine Development Act](#), which would require BARDA to take steps to expand and enhance our nation’s manufacturing capacity for COVID-19 vaccines and products necessary to administer the vaccines.
- Rep. Cook introduced the [Coronavirus County Relief and Stability Act](#) to address the lack of COVID-19 relief funding for small and midsize counties.

SENATE:

- Sens. Stabenow and Wicker led a bipartisan group of 41 senators in a [letter](#) to Sens. Blunt and Murray, calling for additional assistance for community health centers in the next coronavirus relief package.

- Sen. Murray sent a [letter](#) to Vice President Pence regarding a new COVID-19 testing lead to replace Admiral Brett Giroir.
- Sen. Baldwin sent a [letter](#) to FDA Commissioner Hahn regarding regulation and oversight of hydroxychloroquine.

Administration

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS [issued](#) a Second Amendment to Declaration under the Public Readiness and Emergency Preparedness Act for Medical Countermeasures Against COVID-19.

NATIONAL INSTITUTES OF HEALTH

- A [study](#) led by researchers in the National Cancer Institute (NCI), in collaboration with researchers from the National Institute of Allergy and Infectious Diseases (NIAID), as well as the Walter Reed National Military Medical Center, and four other hospitals nationally, has identified a potential approach to treat patients with severe COVID-19.

FOOD AND DRUG ADMINISTRATION

- FDA publicly posted test performance data from four more antibody, or serology, test kits on [open.fda.gov](#) from its independent performance validation study effort with NIH's National Cancer Institute (NCI).
- FDA [approved](#) Recarbrio (a combination of imipenem-cilastatin and relebactam) to treat hospital-acquired bacterial pneumonia and ventilator-associated bacterial pneumonia (HABP/VABP) in patients 18 years of age and older.
- FDA issued a new [video resource](#) explaining the different categories of tests in the fight against COVID-19: diagnostic tests and antibody tests.
- FDA approved an abbreviated new drug application for [dexmedetomidine hydrochloride in 0.9% sodium chloride injection](#) (ANDA 209307), indicated for sedation of initially intubated and mechanically ventilated patients during treatment in an intensive-care setting and sedation of non-intubated patients prior to and/or during surgical and other procedures.
- FDA announced that on Tuesday, June 9, 12:00 pm – 1:00 pm ET, the FDA will launch a [webinar series](#) on the topic of [Respirators for Health Care Personnel Use during COVID-19 Pandemic](#).
- FDA issued a [letter](#) to clinical laboratory staff and health care providers about a safety risk with using transport media and SARS-CoV-2 testing platforms that are not compatible.
