



DAILY COVID-19 UPDATE

June 8, 2020

WHAT HAPPENED TODAY

Today, Senate Majority Leader Mitch McConnell (R-KY) stated the economic fallout from the coronavirus pandemic "may have bottomed out earlier than expected" with millions of jobs being added back to the economy as states re-open.

Additionally, the Federal Reserve ("Fed") announced it will expand the Main Street Lending Program (MSLP) to allow more small- and medium-sized businesses to receive support. Among other things, the Fed lowered the minimum loan amount, raised the maximum loan limit, adjusted the principal repayment schedule to begin after two years, and extended the term to five years to provide borrowers with greater flexibility in repaying the loans. The Fed expects the MSLP to be open for lending "soon."

LATEST STATISTICS

There are a total of **7,073,970** confirmed cases worldwide, 404,304 deaths and 3,172,476 people have recovered.

There are **1,954,936** confirmed cases of the coronavirus in the U.S., 110,845 deaths and 506,367 people have recovered.

ECONOMIC UPDATE

Congressional

HOUSE:

- The House Ways and Means Committee [issued](#) a press release on, "The Benefits of Extending Enhanced Unemployment Compensation."

PUBLIC HEALTH UPDATE

Congressional

HOUSE:

- Energy and Commerce Republicans published a blog post titled, "[CDC Announces \\$140 Million for Flu Preparedness.](#)"
- Rep. Davison introduced H.R. 7094, the [Flexibility for States and Localities Act](#), which would allow states greater discretion over how to spend funds allocated to states through the \$150 billion Coronavirus Relief Fund that Congress created for states to address the coronavirus pandemic, within the CARES Act.
- House Majority Leader Hoyer issued a [statement](#) after HHS announced new requirements for racial and ethnic data collection with coronavirus testing to begin August 1.

SENATE:

- More than 100 senators and representatives sent a [letter](#) to HHS Secretary Azar and CMS Administrator Verma regarding a more comprehensive response to the threat of COVID-19 in nursing homes.
- Sen. Shaheen introduced the [Emergency Care for Veterans During the COVID-19 Pandemic Act](#), which would ensure veterans can access emergency care without incurring massive medical bills during this crisis.

Administration

THE WHITE HOUSE

- The White House provided a [readout](#) from a governors briefing, led by Vice President Pence, on COVID-19 response and re-opening efforts.

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS [announced](#) initiatives to address the disparate impact of COVID-19 on African Americans and other racial and ethnic minorities.
- HHS' Substance Abuse and Mental Health Services Administration (SAMHSA) [awarded](#) nearly \$66 million in grants to provide training, education, and resources at no cost to individuals, communities, states, and the healthcare field to improve the delivery of mental and substance use disorder treatment in America's communities.

CENTERS FOR DISEASE CONTROL AND PREVENTION

- CDC [published](#) a Morbidity and Mortality Weekly Report (MMWR) titled, "Knowledge and Practices Regarding Safe Household Cleaning and Disinfection for COVID-19 Prevention — United States, May 2020." The report found that in an attempt to kill the coronavirus, 39% of Americans are engaging in "non-recommend, high-risk practices," including using bleach on food, applying household cleaning or disinfectant products to their skin and inhaling or ingesting such products.

FOOD AND DRUG ADMINISTRATION

- The FDA reissued [Emergency Use Authorizations](#) (EUAs) revising which types of respirators can be decontaminated for reuse.
- The FDA issued an updated [FDA COVID-19 Response At-A-Glance Summary](#) that provides a quick look at facts, figures and highlights of the agency's response efforts.
- The FDA has published and continues to update [extensive resources on COVID-19 and medical devices](#) to help answer questions.
- The FDA issued new [guidance](#) issued that expands the availability and capability of non-invasive monitoring devices. These remote devices facilitate patient monitoring while reducing patient and healthcare provider contact and exposure to COVID-19 for the duration of the COVID-19 public health emergency.
