WHAT HAPPENED TODAY

Yesterday, Joe Biden, the former Vice President and the presumptive Democratic nominee for President, unveiled an [**eight-step plan to safely reopen the economy**](#) amid the coronavirus pandemic. Biden's plan calls for increased COVID-19 testing, building a national contact tracing task force, ensuring anyone who must return to work has access to personal protective equipment (PPE), and guaranteeing paid sick leave for anyone who gets sick with COVID-19, among other things.

Notably, Dr. Anthony Fauci, Director of the National Institute of Allergy and Infectious Diseases, said earlier this week during a conference held by the Biotechnology Innovation Organization (BIO), that he is "almost certain" more than one vaccine candidate for COVID-19 will be successful. He also warned that the deadly coronavirus outbreak is far from over,

FEDERAL RESERVE ("FED"):

- Treasury Secretary Steven Mnuchin [spoke](#) with UK Chancellor of the Exchequer Rishi Sunak and discussed safely reopening economies.

PUBLIC HEALTH UPDATE

Congressional

HOUSE:

- Reps. Pallone and Neal issued a [statement](#) after CMS released guidance addressing concerns the Chairmen recently raised with the agency regarding the seizure of nursing home residents' economic impact payments.
- Reps. Torres-Small and Newhouse introduced the [***Increasing Rural Health Access During the COVID-19 Public Health Emergency Act***](#), a bipartisan bill that would invest \$50 million in rural communities to increase access to telehealth during the COVID-19 pandemic. Senators McSally and Jones introduced companion legislation in the Senate.
- Reps. Thompson and Butterfield introduced the bipartisan [***Helping Ensure Access to Local TeleHealth***](#), or the HEALTH Act. The bill will codify Medicare reimbursement for community health centers and rural health clinics for telehealth services.

SENATE:

- Sen. Grassley and Wyden sent a [letter](#) to HHS Secretary Azar asking the Department to publish which healthcare providers received portions of the \$210 billion in stimulus money allocated by Congress. They specifically requested increased transparency through a "single, comprehensive and publicly available data source that...shows the amount of funding received by each provider."
- Sens. Warner, Jones, Durbin, and Shaheen led 35 of their colleagues in a [letter](#) to House and Senate leaders, urging them to ensure that any upcoming COVID-19 relief bill includes strong provisions to expand access to quality and affordable healthcare coverage in the wake of this public health crisis.
- Sens. Gillibrand and Markey led four other senators in a [letter](#) to President Trump urging the reinstatement of the National Security Council's Global Health Security Directorate to protect America from COVID-19 as well as future pandemics.
- Sens. Loeffler, Ernst, and Cruz introduced the [***Bring Entrepreneurial Advancements to Consumers Here In North America \(BEAT CHINA\)***](#) Act to incentivize pharmaceutical and medical device and supply manufacturers to relocate to the United States.
- Sen. Thune introduced legislation that would extend for two years the FDA's [***Temporary Policy for Preparation of Certain Alcohol-Based Hand Sanitizer Products During the Public Health Emergency***](#). Extending the FDA's guidance will grant additional certainty for ethanol operations that have made investments or changes in operations to serve the current and projected need for hand sanitizer, providing a longer timeline to recoup such costs.

Administration

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS' Office for Civil Rights issued [guidance](#) on how HIPAA permits covered healthcare providers to contact their patients who have recovered from COVID-19 to inform them about how they can donate their blood and plasma containing antibodies to help other patients with COVID-19.

- CDC released a Morbidity and Mortality Weekly Report titled, "[**Impact of the COVID-19 Pandemic on Emergency Department Visits — United States, January 1, 2019–May 30, 2020.**](#)"

- CDC [**released a social media toolkit**](#) to help localize efforts in responding to COVID-19. The toolkit provides messages and graphics that help ensure current, correct messaging from a trusted source, create collateral materials, and share resources.
- CDC released a [**forecast**](#) for new hospitalizations amid the COVID-19 pandemic, predicting there will be between 2,500 and 12,000 new COVID-19 hospitalizations per day in the U.S.
