June 18, 2020

WHAT HAPPENED TODAY

During an [interview](#) with Fox News last night, President Trump stated COVID-19 is "fading away" and noted that while spikes will be addressed "very quickly...we won't be closing the country again." Trump also called for schools to reopen, noting the number of coronavirus cases among children "are very, very small, almost nonexistent."

Yesterday, the House Energy and Commerce Health Subcommittee held a hearing to examine the disproportionate impacts of COVID-19 on communities of color. Among other things, witnesses recommended aggressive testing and contact tracing in minority communities, implicit bias training for providers, and increased broadband internet development for access to telehealth.

Notably, Federal Reserve Chairman Jerome Powell made his most explicit [statement](#) yet in support for

SENATE:

PUBLIC HEALTH UPDATE

Congressional

HOUSE:

- 66 House lawmakers sent a [letter](#) to Speaker Pelosi and Minority Leader McCarthy regarding a 22 month extension of CMS' emergency telehealth waivers to be included in a potential Phase Four coronavirus aid package.

SENATE:

- Sens. Cruz and Blackburn introduced the [Equal Access to Care Act](#) - legislation to expand access to telemedicine during the coronavirus emergency period by allowing licensed health care providers to treat patients over the phone and online wherever the patient is located.
- Sens. Duckworth and Durbin introduced the [COVID-19 Special Enrollment Period Act](#) to provide uninsured Americans in Illinois and throughout the country the freedom to purchase health insurance coverage through the federal health insurance marketplace exchange by establishing a one-time special enrollment period (SEP) beginning on July 1, 2020 and ending on October 1, 2020.

Administration

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS through the Health Resources and Services Administration (HRSA), [announced](#) awards totaling \$107.2 million to 310 recipients to increase the health workforce in rural and underserved communities. Recipients across 45 states and U.S. territories received funding to improve the quality, distribution and diversity of health professionals serving across the country.

FOOD AND DRUG ADMINISTRATION

- FDA took an additional step in harnessing real-world data to help inform the agency's overall response to COVID-19 by [announcing](#) its participation in the COVID-19 Diagnostics Evidence Accelerator, a multi-stakeholder collaborative project to advance the development of diagnostics.
- FDA published the [Statistical Considerations for Clinical Trials During the COVID-19 Public Health Emergency Guidance for Industry](#). This guidance shares recommendations on statistical considerations to address the impact of COVID-19 on meeting objectives of clinical trials conducted during this public health emergency.
- FDA issued [warning letters](#) to three companies for marketing adulterated and misbranded COVID-19 antibody tests.

INTERNAL REVENUE SERVICE

- The IRS [alerted](#) nursing home and other care facilities that Economic Impact Payments (EIPs) generally belong to the recipients, not the organizations providing the care. The

IRS issued this reminder following concerns that people and businesses may be taking advantage of vulnerable populations who received the Economic Impact Payments.

- The IRS **advised** that new rules under the CARES Act provide flexibility for health care spending that may be helpful in the current environment where more people may need at-home services due to measures to fight the coronavirus.
