



DAILY COVID-19 UPDATE

June 26, 2020

The Daily COVID-19 Update will be taking a break from June 29 to July 3 and will resume on July 6. Have a safe and happy Fourth of July!

WHAT HAPPENED TODAY

Today, the White House Coronavirus Task Force held its first **briefing** since April 27. Vice President Pence and NIAID Director Dr. Fauci urged young people to be more vigilant in assessing their risks and taking better precautions in order to prevent spreading the virus to vulnerable Americans. Dr. Fauci also noted that young people who are asymptomatic are driving a "paradigm shift" in the pandemic by increasing community spread.

In a letter, Treasury Secretary Steven Mnuchin **notified** House Ways and Means Chairman Richard Neal (D-MA) that the agency will provide relevant congressional committees with full access to

loan data from the Paycheck Protection Program (PPP). He stated borrower names and loan amounts will be provided "with the understanding that non-public, personally identifiable and commercially sensitive business information will be treated as confidential."

Additionally, the Federal Reserve released its stress tests of the banking system for 2020, which stated U.S. banks are strong enough to withstand the crisis, but the agency restricted dividend payouts and buybacks in order to ensure banks remain well capitalized.

Notably, in an interview yesterday, NIAID Director Dr. Fauci indicated Trump administration health officials are considering a drastic shift to "pool testing," whereby COVID-19 test samples from numerous people would be tested together in an attempt to more rapidly identify and isolate infected individuals.

HOUSE:

- House Select Subcommittee on the Coronavirus Crisis Chairman Clyburn and House Democrats from Texas, Colorado, Illinois, New Jersey, and Pennsylvania sent a [letter](#) to HHS Secretary Azar asking him to reverse the administration's decision to end federal funding for 13 coronavirus testing sites in those states at the end of the month. HHS has denied this change will affect the testing sites.
