July 7, 2020

### WHAT HAPPENED TODAY

Today, President Trump [\*\*formally withdrew\*\*](#) the U.S. from the World Health Organization amid the coronavirus pandemic.

Notably, Senate Majority Leader Mitch McConnell [\*\*expressed support\*\*](#) for another round of stimulus checks for Americans, saying "it could well be a part of" the next coronavirus relief package. He added that the Senate GOP legislative proposal should be released "in a few weeks" and will likely focus on "liability reform, kids in school, jobs, and healthcare" and could also include aid for local and state governments.

Meanwhile, Labor Secretary Eugene Scalia stated the boosted unemployment benefit of \$600 per week, which is set to expire on July 31, is [\*\*no longer needed\*\*](#) "going forward."

There are **2,966,409** confirmed cases of the coronavirus in the U.S., 130,902 deaths and 924,148 people have recovered.

### *Congressional*

#### **SENATE:**

- Senate Banking Committee Ranking Member Sherrod Brown (D-OH) issued a statement on the borrowers of Paycheck Protection Program (PPP) loan data.

### *Administration*

#### **TREASURY:**

- Secretary Mnuchin issued a statement on loans to passenger air carriers.
- Secretary Mnuchin issued a statement on the Main Street Lending Program.

#### **CONSUMER FINANCIAL PROTECTION BUREAU (CFPB):**

- The CFPB issued a final rule concerning small dollar lending in order to maintain consumer access to credit and competition in the marketplace.

## PUBLIC HEALTH UPDATE

### *Congressional*

#### **HOUSE:**

- Rep. Gonzalez and Johnson led 89 of their colleagues in a [letter](#) to Secretary Azar, urging HHS to direct additional funds for children's hospitals impacted by the COVID-19 pandemic.
- Rep. Griffith introduced the [\*\*Granny Pods Study Act of 2020\*\*](#), legislation that would require CMS to study the possibility of reimbursing for expenses related to care provided in "granny pods" for loved ones with long-term mental and physical impairments.

#### **SENATE:**

- Democratic Health Committee leaders Sens. Murray and Wyden as well as Reps. Pallone, Scott, and Neal sent a [letter](#) to HHS Secretary Azar, Labor Secretary Scalia, and Treasury Secretary Mnuchin expressing serious concerns with guidance recently issued by the Trump Administration allowing insurance plans and group health plans to deny coverage claims for COVID-19 tests and other related services.
- Sen. Peters released a [report](#) on the impact of the coronavirus pandemic on residents and workers in nursing homes.

### *Administration*

#### **THE WHITE HOUSE**

- Second Lady Karen Pence [participated](#) in the launch of the PREVENTS National Health Campaign called REACH at the National Press Club. She emphasized the need to address suicide and measures we can take to prevent it as well as the need to focus on one's mental health and emotional well-being.

#### **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

- HHS and the Department of Defense (DoD) jointly [announced](#) a \$1.6 billion agreement with Novavax, Inc. of Gaithersburg, Maryland, to demonstrate commercial-scale manufacturing of the company's COVID-19 investigational vaccine.
- HHS and the Department of Defense (DoD) [announced](#) an agreement with Regeneron, Inc. of Tarrytown, New York, to demonstrate commercial-scale manufacturing of the company's COVID-19 investigational anti-viral antibody treatment, REGN-COV2.
- HHS [announced](#) free COVID-19 testing in Jacksonville, Florida; Baton Rouge, Louisiana; and Edinburg, Texas. Surge testing efforts will temporarily increase federal support to communities where there has been a recent and intense level of new cases and hospitalizations related to the ongoing outbreak.

#### **FOOD AND DRUG ADMINISTRATION**

- FDA issued an [\*\*Emergency Use Authorization\*\*](#) (EUA) for a COVID-19 antigen diagnostic test, the BD (Becton Dickinson) Veritor System for Rapid Detection of SARS-CoV-2. This is the second antigen test the FDA has authorized for the detection of SARS-CoV-2 antigens.
- The FDA added content to the question-and-answer appendix in its guidance titled "[\*\*Conduct of Clinical Trials of Medical Products during COVID-19 Public Health Emergency\*\*](#)."
