



DAILY COVID-19 UPDATE

July 16, 2020

WHAT HAPPENED TODAY

Senate Majority Leader Mitch McConnell (R-KY) continues to outline aspects of his COVID-19 relief package, which is expected to be released next week. Yesterday, he **announced** there will be "heavy emphasis" on education in the future legislation, as "we need to find a way to safely get back to work ... and the federal government will have to play a financial role in helping to make that possible."

Notably, the Federal Reserve released its **Beige Book** that showed "economic activity increased in almost all Districts, but remained well below where it was prior to the COVID-19 pandemic." Additionally, the report noted "outlooks remained highly uncertain, as contacts grappled with how long the COVID-19 pandemic would continue and the magnitude of its economic implications."

There are a total of **13,666,118** confirmed cases worldwide, 586,369 deaths and 7,635,655 people have recovered.

There are **3,546,871** confirmed cases of the coronavirus in the U.S., 138,040 deaths and 1,075,882 people have recovered.

Earlier this week, the House Homeland Security Committee held a [hearing](#) on federal and state supply preparedness for COVID-19 and future pandemics. The witness panel recommended improving supply distribution and prioritization; using field stations and alternative care sites to decompress hospitals; supplementing materials from the Strategic National Stockpile (SNS) with production and purchasing; early interventions to increase the production of critical supplies; and including pandemics in the definition of a major disaster declaration, among other things.

ECONOMIC UPDATE

Congress

HOUSE:

- Reps. Suzan DelBene (D-WA), Denny Heck (D-WA), Jackie Walorski (R-IN), and Cathy McMorris Rodgers (R-WA), along with 111 other members, [sent a letter](#) to IRS Commissioner Rettig urging the agency to resolve several issues around Economic Impact Payments.
- Rep. Tom Rice (R-SC) [will introduce](#) legislation to provide a tax credit for businesses to safely reopen and pay for extra safety measures amid the coronavirus pandemic.

Administration

FEDERAL RESERVE ("FED"):

- The Fed [announced](#) an extension of a rule change to bolster the effectiveness of the Small Business Administration (SBA) Paycheck Protection Program (PPP).

TREASURY:

- Treasury released a [readout](#) from Secretary Mnuchin's call with Finance Ministers of Australia, Canada, and the United Kingdom, in which they discussed combating unemployment and job support in industries adversely impacted by the COVID-19 pandemic.

INTERNAL REVENUE SERVICE (IRS):

- The IRS **released** its annual “Dirty Dozen” list of tax scams with a special emphasis on aggressive and evolving schemes related to coronavirus tax relief, including Economic Impact Payments.

CONSUMER FINANCIAL PROTECTION BUREAU (CFPB):

- The CFPB **issued** an updated Complaint Bulletin, analyzing the more than 8,000 complaints it received from January through May 2020 that mention coronavirus or related terms.

SECURITIES AND EXCHANGE COMMISSION (SEC):

- The SEC, Municipal Securities Rulemaking Board (MSRB), and Financial Industry Regulatory Authority (FINRA) **announced** the opening of registration for a virtual Compliance Outreach Program for Municipal Advisors.

PUBLIC HEALTH UPDATE

Congressional

HOUSE:

- Democratic members of the House Select Subcommittee on the Coronavirus Crisis sent a **letter** to cabinet agency leaders requesting documents and information regarding contracts awarded by the Administration to procure personal protective equipment (PPE), testing supplies, and other medical equipment. In addition, they're also requesting the Administration's plans to meet the urgent need for these supplies as coronavirus cases rise across the U.S.
- 12 representatives sent a **letter** to congressional leaders urging the implementation of targeted and time-limited COVID-19 liability protections for healthcare providers, facilities, businesses, and non-profit organizations that work to follow proper public health guidelines to protect everyone from the current pandemic.

SENATE:

- Sen. Harris (D-CA) announced the **COVID-19 Bias and Anti-Racism Training Act**, legislation to ensure health providers and other individuals involved in COVID-19 testing, treatment, vaccine distribution, and response receive bias and anti-racism training.
- Sen. Hassan sent a **letter** to HHS and the U.S. Postal Service about the two collaborating to improve patient and public health by enhancing the accuracy with which electronic health record (EHR) systems can share data with one another.

Administration

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- Yesterday, HHS Chief Information Officer Jose Arrieta and CDC Director Robert Redfield provided an **update** for members of the media on HHS efforts to gather and disseminate real-time hospital data on COVID-19.

FOOD AND DRUG ADMINISTRATION

- The FDA updated its **Frequently Asked Questions on Testing for SARS-CoV-2**. The revised FAQs now include a list of laboratories that have been removed from the notification list because FDA has determined that there are significant problems with its test that cannot be, or have not been, addressed in a timely manner and should no longer be used.

LABOR UPDATE

Congressional

HOUSE:

- Ways and Means Republicans **introduced** two new bills as part of their policy agenda to help Americans returning safely to a healthy workplace. These bills, the *Healthy Workplace Tax Credit* introduced by Rep. Rice (R-SC) and the *Workplace Testing Tax Credit* introduced by Rep. Schweikert (R-AZ), will help businesses safely and responsibly reopen our economy and protect the health and well-being of workers during the COVID-19 pandemic.
- Ways and Means Republicans published a coronavirus bulletin titled, "**Retail Sales Up, Jobless Claims Down: Reopening Slowly, Safely.**"

Administration

DEPARTMENT OF LABOR:

- DOL released its **Unemployment Insurance Weekly Claims Report** for the week ending on July 11.
- DOL's Wage and Hour Division (WHD) announced **significant steps to streamline optional-use forms** that workers can use to request and employers can use to coordinate leave under the Family and Medical Leave Act (FMLA). WHD also published

a **Request for Information** (RFI) in the Federal Register seeking the public's feedback on the law's administration and use.
