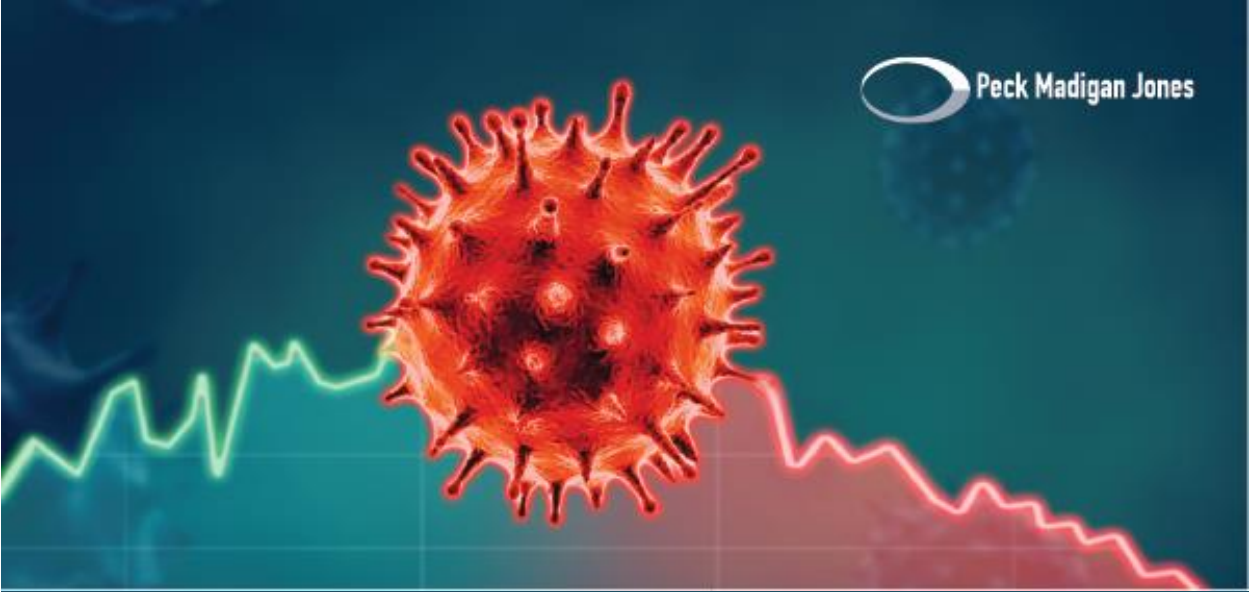




DAILY COVID-19 UPDATE

WHAT HAPPENED TODAY

Today, Senate Democratic Leader Chuck Schumer (D-NY) stated the Senate GOP's new slimmed-down coronavirus relief package **"won't pass"** in a procedural vote on Thursday. He indicated Majority Leader Mitch McConnell (R-KY) is "rush[ing] it to the floor two days after releasing it," because "he's looking for political cover."

Meanwhile, Leader McConnell noted Democrats are **obstructing progress** on bipartisan relief because they don't want any aid to "reach American families before the election."

Treasury Secretary Mnuchin has been working towards reaching a deal to fund the government past September 30. He **expressed** uncertainty in regards to whether a compromise can be reached on additional coronavirus stimulus but stated reaching a

- Reps. Maloney (D-NY), Krishnamoorthi (D-IL) and Clyburn (D-SC) sent a [letter](#) to HHS Secretary Azar requesting a briefing on a vaccine distribution plan.

Administration

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS issued [guidance](#) under the Public Readiness and Emergency Preparedness Act (PREP Act) to expand access to safe and effective COVID-19 vaccines when they are made available. This guidance authorizes state-licensed pharmacists to order and administer COVID-19 vaccinations to persons ages 3 or older.

FOOD AND DRUG ADMINISTRATION

- The FDA has [deactivated](#) the FDA registration for 340 foreign establishments that failed to identify a U.S. Agent as required by FDA's regulations. Of these, 131 establishments list devices that are essential to the COVID-19 pandemic response.
