WHAT HAPPENED TODAY

After a failed vote on Senate Majority Leader Mitch McConnell's (R-KY) targeted coronavirus relief bill, prospects that a stimulus deal will be reached prior to the election are **highly unlikely**. Sen. Pat Roberts (R-KS) stated, "It's sort of a dead-end-street." Meanwhile, Speaker Nancy Pelosi (D-CA) told House lawmakers, "We don't want to go home without a bill, but...When you are in a negotiation, the last place to get weak knees is at the end."

During a press conference yesterday, President Trump stated the U.S. is "**rounding the final turn** [on the pandemic] and we're going to have vaccines very soon..." NIAID Director Dr. Anthony Fauci indicated he disagrees with the president, noting, "we're plateauing at around 40,000 cases a day and deaths are around 1,000." He also expressed concern we could see a surge in cases following Labor Day weekend.

There are a total of **28,287,928** confirmed cases worldwide, 911,591 deaths and 19,052,460 people have recovered.

There are **6,430,860** confirmed cases of the coronavirus in the U.S., 192,616 deaths and 2,403,511 people have recovered.

Less than a month after President Trump's executive order to extend \$400 in enhanced unemployment benefits, [**states are being informed**](#) by the Federal Emergency Management Agency (FEMA) that funding is running out. Texas, Tennessee, Montana, Iowa, and Arizona have all been notified that FEMA's Lost Wages Assistance Program will no longer supplement the additional unemployment benefits.

Notably, the federal budget deficit surpassed \$3 trillion through August [according to data](#) released by the Treasury. The federal government spent over \$6 trillion so far this year, a figure that increased largely due to emergency COVID-19 related spending.

Congressional

SENATE

- Sen. Blunt (R-MO) sent a [**letter**](#) to CDC Director Redfield asking whether \$6 billion proposed by Republicans in their next phase of COVID-19 relief would be adequate for its vaccine distribution effort.
- Sens. Booker (D-NJ) and Durbin (D-IL) [**introduced**](#) the *Abiding by U.S. Commitments* Act, which would ensure the United States fulfills its commitments to the World Health Organization by providing \$118.9M and strengthen global efforts to develop a vaccine for COVID-19.
- Sen. Baldwin (D-WI) [**introduced**](#) the *COVid Enrollment Response (COVER) Act* would invest in outreach and enrollment assistance to help more Americans find quality, affordable health insurance.

- As of today, 247 tests are authorized by FDA under EUAs; these include 197 molecular tests, 46 antibody tests, and 4 antigen tests.
