



## DAILY COVID-19 UPDATE

September 21, 2020

### WHAT HAPPENED TODAY

The odds of passing another coronavirus relief package prior to the election significantly narrowed this past Friday with the death of Justice Ruth Bader Ginsburg. The political battle to fill the vacant Supreme Court seat has quickly overshadowed lawmakers' fall agenda on Capitol Hill and shows no sign of abating.

A recent Congressional Budget Office (CBO) report showed the emergency COVID-19 relief bills passed earlier this year added 4.7% to the gross domestic product (GDP) in 2020 and will add another 3.1% in 2021. The Federal Reserve estimates the economy will shrink by 3.7% this year, meaning without the congressional relief measures, the economic downturn could have been nearly twice as severe.

There are a total of **31,175,205** confirmed cases worldwide, 962,076 deaths and 21,294,229 people have recovered.

There are **6,835,013** confirmed cases of the coronavirus in the U.S., 199,743 deaths and 2,590,695 people have recovered.

#### **SENATE:**

- Senate Banking Committee Ranking Member Sherrod Brown (D-OH) and Senator Mark Warner (D-VA) urged the Government Accountability Office (GAO) to report on companies' increased use of subcontracted and contingent workers, including a study on if these workers have faced additional economic hurdles due to the COVID-19 pandemic.
- Senate Finance Committee Ranking Member Ron Wyden (D-OR), along with 31 other Senators, urged President Trump to work with Congress to provide emergency rental assistance and protections.
