### WHAT HAPPENED TODAY

Today, the Senate HELP Committee held a hearing on the federal response to the coronavirus pandemic. Dr. Fauci noted there is "growing optimism" that scientists will find one or more safe and effective COVID-19 vaccines by the end of the year or early 2021, with enough doses available for all Americans by next April. CDC Director Dr. Redfield warned that as many as 90% of Americans still haven't been infected with the virus and are still susceptible to it. Dr. Hahn vowed that the FDA will not authorize or approve any COVID-19 vaccine before it has met the rigorous expectations for safety and effectiveness.

Additionally, Federal Reserve Chairman Jerome Powell testified before the House Select Subcommittee on the Coronavirus Crisis, during which he remained firm on previous statements regarding the need for additional fiscal support and to

follow public health protocols in order to mitigate the impact of the virus on the economy. When asked about the size and scope of an additional COVID-related stimulus package, Chairman Powell responded he has a "strong desire to not play a role in [these] discussions."

Yesterday, the Advisory Committee on Immunization Practices (ACIP), which advises the CDC, was slated to vote on formal recommendations for which groups would be prioritized when limited doses of a COVID-19 vaccine become available. However, the committee made a decision to wait until Phase 3 clinical data about the characteristics and logistical requirements of the vaccine is available.

Notably, only 42% of voters now say they are likely to get a coronavirus vaccine when it becomes available, down from 58% in July.

## PUBLIC HEALTH UPDATE

## **Congressional**

### **SENATE**

- Sens. Murray (D-WA) and Schumer (D-NY) led 32 of their Senate Democratic colleagues in introducing the *Science and Transparency Over Politics* (STOP) Act, legislation to fight back against political interference in the work of experts and the nation's public health agencies to respond to the COVID-19 pandemic.
- Sens. Casey (D-PA) and Wyden (R-OR) released a report titled, "The Cost of Inaction: 11 Deaths in an Hour - An Update on the Trump Administration's Response to COVID-19 in Nursing Homes."

## **Administration**

### **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

- HHS announced upcoming action by CDC to provide \$200 million to 64 jurisdictions through the existing Immunizations and Vaccines for Children cooperative agreement to help states prepare for the COVID-19 vaccine.

### **CENTERS FOR MEDICARE & MEDICAID SERVICES**

- CMS announced the availability of up to \$165 million in supplemental funding to states currently operating Money Follows the Person (MFP) demonstration programs. States could use this funding opportunity to plan and implement the use of telehealth for nursing facility transition activities that would normally be conducted in-person or to redesign service delivery models to reduce the risk of COVID-19 infection among MFP participants.

### **NATIONAL INSTITUTES OF HEALTH**

- A fourth Phase 3 clinical trial evaluating an investigational vaccine for COVID-19 has begun enrolling up to 60,000 adult volunteers at up to nearly 215 clinical research sites in the U.S. and internationally. The trial is designed to evaluate if the investigational Janssen COVID-19 vaccine can prevent symptomatic COVID-19 after a single dose regimen.
