



DAILY COVID-19 UPDATE

September 30, 2020

WHAT HAPPENED TODAY

Today, Speaker Pelosi (D-CA) and Secretary Mnuchin met in-person, for the first time since stimulus negotiations stalled over a month ago, to discuss the House's scaled-down \$2.2 trillion coronavirus relief package.

Following the 90-minute meeting, Secretary Mnuchin noted "there is more work to do" before the pair reach an agreement. Separately, Speaker Pelosi stated she and Secretary Mnuchin "found areas where [they] are seeking further clarification" and noted "conversations will continue." She also announced the House will proceed with a vote tonight on their stimulus bill.

Meanwhile, Senate Majority Leader Mitch McConnell (R-KY) indicated the updated HEROES Act is a "far-left wish list" that contains the same "poison pills" as

the previous version of the proposal. He also added the price tag of the bill is far too high.

Additionally, the Treasury announced it will begin forgiving Paycheck Protection Program (PPP) loans by late this week or early next week. Loan applicants are expected to be approved quickly, apart from those with loans over \$2 million.

HOUSE:

- House Small Business Committee Chairwoman Nydia Velazquez (D-NY) issued a statement regarding the scaled-back HEROES Act.

- Treasury announced that it has closed loans to seven large passenger air carriers in accordance with the CARES Act.

PUBLIC HEALTH UPDATE

Congressional

HOUSE:

- Speaker Pelosi issued a statement following a meeting with Treasury Secretary Mnuchin on coronavirus relief.

SENATE:

- Senate Majority Leader Mitch McConnell (R-KY) delivered remarks on the Senate floor regarding COVID-19 relief.

Administration

THE WHITE HOUSE

- The White House Press Secretary issued a statement regarding the Global Health Security Agenda Annual Report.

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS announced five cooperative agreements to health information exchange organizations (HIEs) to help support state and local public health agencies in their efforts to respond to public health emergencies, including disasters and pandemics such as COVID-19.

CENTERS FOR MEDICARE & MEDICAID SERVICES

- CMS announced an update to the methodology the agency employs to determine the rate of COVID-19 positivity in counties across the country. This information is critical to nursing homes, which are required to test their staff for COVID-19 at a frequency based on the positivity rate of their respective counties.

NATIONAL INSTITUTES OF HEALTH

- NIH awarded nearly \$234 million to improve COVID-19 testing for underserved and vulnerable populations. A part of the Rapid Acceleration of Diagnostics (RADx) initiative, the RADx Underserved Populations (RADx-UP) program will support 32 institutions across the United States and will focus on populations disproportionately affected by the pandemic.
- A Phase 1 trial of an investigational mRNA vaccine to prevent SARS-CoV-2 infection has shown that the vaccine is well-tolerated and generates a strong immune response in older adults.
