### WHAT HAPPENED TODAY

Today, in an [interview](#) with Fox Business Network, President Donald Trump declared he is now negotiating a "bigger deal than airlines" that could also include another round of stimulus checks for Americans, among other things. He stated, "I shut down talks two days ago because they weren't working out. Now they're starting to work out...I think we have a really good chance of doing something."

However, Speaker Nancy Pelosi (D-CA) asserted the House will not back a piecemeal bill to rescue any industry without an agreement with the White House and Senate Republicans on a larger coronavirus relief package.

## PUBLIC HEALTH UPDATE

### *Congressional*

#### HOUSE

- Reps. Pallone (D-NJ), Eshoo (D-CA), and DeGette (D-CO) sent a [letter](#) to HHS Secretary Azar expressing concerns about the Department allowing marketing of laboratory-developed COVID-19 tests without FDA review.
- Rep. Pallone (D-NJ) sent a [letter](#) to White House Chief of Staff Mark Meadows urging him to allow contact tracers to investigate the large outbreak of coronavirus cases surrounding President Trump and White House staff.

#### SENATE

- Sens. Schumer (D-NY) and Klobuchar (D-MN) [unveiled](#) S.Con.Res. 49, a resolution that calls for mandatory mask wearing in all public areas of Senate buildings, social distancing per guidance, and calls for the Senate to implement a testing and contract tracing system, among other actions.
- Sens. Tillis (R-NC) and Blackburn (R-TN) [introduced](#) the *Defend COVID Research from Hackers Act*, legislation that would give the President the authority to sanction foreign nations that threaten public health and national security by attempting to steal American research on COVID-19.

#### FOOD AND DRUG ADMINISTRATION
