WHAT HAPPENED TODAY

Today, Secretary Mnuchin spoke with Speaker Nancy Pelosi (D-CA), Chief of Staff Mark Meadows, and Senate Majority Leader Mitch McConnell (R-KY) regarding relief negotiations, but after his discussions he stated it "would be difficult" to pass any stimulus before Election Day. Secretary Mnuchin added if President Trump wins reelection he will be "very focused" on additional aid, so "that's part of the reason to continue to work on this."

Speaker Pelosi's spokesperson, Drew Hammill, tweeted the Speaker and Secretary Mnuchin had a "productive" conversation, but the two continue to disagree over a national COVID-19 testing plan. The two are scheduled to speak again tomorrow.

Additionally, in an interview on CNN, Speaker Pelosi dismissed concerns by the bipartisan Problem

HOUSE

- A bipartisan group of senators sent a [letter](#) to HHS Secretary Azar expressing concern about changes in reporting requirements for health care providers that received support from the Provider Relief Fund (PRF).

DEPARTMENT OF HEALTH AND HUMAN SERVICES
