



## DAILY COVID-19 UPDATE

October 20, 2020

### WHAT HAPPENED TODAY

Speaker Pelosi and Secretary Mnuchin met this afternoon for another round of negotiations on a COVID-19 relief bill. Pelosi described herself as optimistic since progress is being made on key provisions, but also noted critical differences remain on state and local aid, income assistance for working families, and liability protections for businesses.

Majority Leader McConnell (R-KY) stated the Senate will take up a coronavirus relief package that is agreed upon by both Pelosi and Mnuchin and cleared by the House. He also mentioned the chamber will debate the bill "at some point" but did not specify whether that would occur before or after the November 3 election.

Notably, President Trump once again reiterated his support for a larger stimulus. He stated "I want to do it even bigger than the Democrats." He also dismissed

**concerns** that Republicans are unwilling to vote for a larger package, saying "not every Republican agrees with me, but they will." Meanwhile, Sen. John Thune (R-SD) indicated it would be "hard" to garner enough GOP support for a coronavirus relief package with a price tag larger than \$1.8 trillion.

This evening, the Senate is slated to vote on a standalone measure to replenish the Paycheck Protection Program (PPP). The bill would provide an additional \$260 billion to the PPP, and allow businesses that previously received loans to apply for new funding.

#### CENTERS FOR DISEASE CONTROL AND PREVENTION

- CDC issued new [interim guidance](#) that strongly recommends all passengers and workers on airplanes, trains, buses, and other public transportation wear masks to mitigate the spread of COVID-19.

#### NATIONAL INSTITUTES OF HEALTH

- NIH Director Dr. Francis Collins penned a [blog post](#) titled, "Two Studies Show COVID-19 Antibodies Persist for Months."
