October 27, 2020

WHAT HAPPENED TODAY

Yesterday, the Senate adjourned until November 9 with little prospect of passing additional COVID-19 legislation prior to the election. Speaker Pelosi and Secretary Mnuchin spoke for nearly an hour on Monday with little indication of any major progress. Following the call, Speaker Pelosi's spokesperson [tweeted](#) that Democrats are waiting on the Trump Administration to accept language on a national testing strategy, and the success of any stimulus "depends on Leader McConnell agreeing" to the comprehensive legislation. Notably, President Trump [stated](#) today that the "best stimulus package you've ever seen" will be passed after the election. President Trump also [tweeted](#) that Speaker Pelosi is the reason an agreement cannot be reached.

Administration

FEDERAL RESERVE ("FED"):

- The Federal Reserve Bank of Philadelphia has [released the coincident indexes](#) for the 50 states for September 2020 showing the indexes increased in 48 states and decreased in two states.

TREASURY:

- The Financial Action Task Force (FATF) [continues to focus](#) on the impact of the COVID-19 pandemic on detecting and countering fraud including attempts to defraud government backed stimulus programs.

INTERNAL REVENUE SERVICE (IRS):

- The IRS [extended its timeline](#) for parents to claim \$500 stimulus payments for each child under the CARES Act.

Congressional

HOUSE

- Speaker Pelosi (D-CA) provided an [update](#) on coronavirus relief.
- 54 House lawmakers sent a [letter](#) to HHS Secretary Azar regarding out-of-pocket costs for COVID-19 testing.

SENATE

- Sen. Booker (D-NJ) [introduced](#) the *Nursing Home Pandemic Protection Act of 2020*, which would require nursing homes to have a crisis plan in place to manage an outbreak, that facilities keep a stockpile of PPE on hand, that nursing homes report communicable diseases, infections, and potential outbreaks, and work to ensure that residents and their families be kept informed of infections inside the facilities.

Administration

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- Four weeks after the Trump Administration [announced](#) it would deploy 150 million state-of-the-art Abbott BinaxNOW COVID-19 tests nationally to assist Governors' ongoing reopening efforts, states have begun to [report back](#) where they are choosing to distribute the rapid, point of care tests.
