WHAT HAPPENED TODAY

Today, Speaker Pelosi (D-CA) sent a [letter](#) to Treasury Secretary Mnuchin, requesting a response to the Democrats' latest coronavirus relief proposal so that "negotiations can continue." She warned that inaction will result in continued negative health and economic effects as the pandemic surges across the country and COVID-19 infections hit record levels in the U.S.

Pelosi also urged the Administration to compromise on unresolved issues such as a national testing strategy, health coverage for unemployed individuals, unemployment benefits, funding for schools, tax credits for low-income families, and liability protections.

Additionally, President Trump [signaled support](#) today for reaching a stimulus deal during the lame duck session, stating "We're going to do a very big package as soon as the election is over."

President Trump [added](#) that extending the Paycheck Protection Program (PPP) in future stimulus "makes sense," as the program has been a success in providing aid to small businesses.

Notably, the Small Business Administration's (SBA) Office of Inspector General [issued a new report](#) that raised concerns of fraud for more than \$78 billion in aid approved through the SBA's Economic Injury Disaster Loan (EIDL) program. According to the report, \$58 billion disbursed in multiple loans used the same IP addresses, email addresses, bank accounts or the same physical addresses, and \$13.4 billion was deposited in accounts that differed from those listed on the initial loan applications. However, Small Business Administrator Carranza claimed the report's findings "rest on hasty, incomplete conclusions."

HOUSE

DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS, through the Health Resources and Services Administration (HRSA), [announced](#) it will distribute approximately \$333 million in first round performance payments to over 10,000 nursing homes.

CENTERS FOR MEDICARE & MEDICAID SERVICES

- CMS [announced](#) steps to ensure all Americans, including the nation's seniors, have access to the COVID-19 vaccine at no cost when it becomes available.

NATIONAL INSTITUTES OF HEALTH

- Researchers at NIH have [discovered](#) a biological pathway that the novel coronavirus appears to use to hijack and exit cells as it spreads through the body. In cell studies, the researchers showed for the first time that the coronavirus can exit infected cells through the lysosome, an organelle known as the cells' "trash compactor."

FOOD AND DRUG ADMINISTRATION

- The FDA [updated an immediately in effect guidance](#), Enforcement Policy for Non-Invasive Remote Monitoring Devices Used to Support Patient Monitoring During the Coronavirus Public Health Emergency.
- The FDA approved two generic drugs indicated to facilitate tracheal intubation and to provide skeletal muscle relaxation during surgery or mechanical ventilation: [succinylcholine chloride injection](#) USP 200 mg/10 mL and [cisatracurium besylate injection](#) USP 10 mg/5 mL.
- As of today, 285 tests are authorized by FDA under EUAs; these include 222 molecular tests, 56 antibody tests, and 7 antigen tests.

DEPARTMENT OF DEFENSE

- Right now, six vaccines for COVID-19 are in development as part of Operation Warp Speed according to the program's chief operating officer, Army Gen.

Gustave F. Perna. At a Heritage Foundation event, he **stated** that once one or more of those vaccines proves both effective and safe, their fast and efficient distribution will require knowing where every dose is at all times, tracking uptake of the vaccine, and making sure vaccine doses are allocated equitably to the entire country simultaneously.
