



DAILY COVID-19 UPDATE

October 30, 2020

WHAT HAPPENED TODAY

Today, Reps. Brady (R-TX), McCarthy (R-CA), Hudson (R-NC), Walden (R-OR), and Granger (R-TX) unveiled H.R. 14, the *Commitment to Defeat the Virus and Keep America Healthy Act*.

The legislation is comprised of numerous bipartisan proposals to address pandemic preparedness and response, domestic manufacturing and supply, strategic national stockpile improvements, public health infrastructure improvements, addressing COVID-19 health disparities, addressing the impact of COVID-19 on mental health and substance use disorder, tax incentives to improve healthcare, Medicare provisions, and appropriations.

Several lawmakers including Senate Republican Whip Thune (R-SD) and co-chair of the House Problem Solvers Caucus Rep. Gottheimer (D-NJ) have expressed optimism that a coronavirus relief package could come together during a lame-duck

session. However, Senate Majority Leader Mitch McConnell (R-KY) stated today a targeted relief package aimed at small businesses, schools, and hospitals "will be something we'll need to do right at the beginning of the year." He added additional relief would be "certainly more modest" than a multi-trillion dollar package.

Additionally, Speaker Pelosi (D-CA) noted yesterday that she believes there is a realistic chance of a COVID-19 bill because "the president has said we would have an agreement after the election." However, some Democratic lawmakers have expressed concern that Leader McConnell will be unwilling to compromise if President Trump loses the election and/or Republicans lose the Senate.

- FDA Commissioner Dr. Stephen Hahn issued a statement noting that as required by a recent executive order, the FDA has published a list of essential medicines, medical countermeasures and critical inputs that are medically necessary to have available at all times in an amount adequate to serve patient needs and in the appropriate dosage forms.

DEPARTMENT OF LABOR

- Since the start of the coronavirus pandemic through Oct. 22, 2020, DOL's Occupational Safety and Health Administration (OSHA) has [cited](#) 144 establishments for violations relating to coronavirus, resulting in proposed penalties totaling \$2,025,431.
