## DAILY COVID-19 UPDATE

November 5, 2020

### WHAT HAPPENED TODAY

Yesterday, CDC Director Dr. Robert Redfield [tweeted](#), "Now is the time to develop a testing strategy to maximize our ability to identify...asymptomatic COVID-19 infections." According to the CDC, 40% of people with coronavirus exhibit no symptoms.

Dr. Redfield's tweet comes as the U.S. recorded its five highest days of COVID-19 cases and the nationwide seven-day average of new infections rose approximately 108% or 89,859 cases in just one month. Coronavirus deaths have also increased 21% in the last two weeks.

Additionally, the Federal Reserve [made no changes](#) to its monetary policy, noting the coronavirus "will continue to weigh on economic activity, employment, and inflation." The Fed will continue to support recovery by holding interest rates at near zero, and will monitor the effects of rising infection rates and the potential for additional Congressional stimulus on the economy.

### LATEST STATISTICS

There are a total of **48,461,273** confirmed cases worldwide, 1,229,758 deaths and 32,030,613 people have recovered.

There are **9,544,315** confirmed cases of the coronavirus in the U.S., 234,300 deaths and 3,743,527 people have recovered.

The U.S. set a one-day record for coronavirus cases yesterday with the number of new infections topping 103,087.
