



## DAILY COVID-19 UPDATE

November 13, 2020

### WHAT HAPPENED TODAY

Today, during a briefing at the Capitol, Speaker Nancy Pelosi (D-CA) called on Republicans to "come to the table" and resume stimulus negotiations but stopped short of offering any new proposals. She stated the focus of the House during the lame-duck session "continues to be on COVID-19 relief" as cases continue to surge across the country.

Speaker Pelosi and Senate Democratic Leader Chuck Schumer (D-NY) continue to push for their \$2.4 trillion HEROES Act as the starting point for negotiations. However, Majority Leader Mitch McConnell (R-KY) has reiterated his objection to a multi-trillion-dollar stimulus and offered the Senate GOP's \$500 billion package as a solution instead.

Additionally, President-elect Joe Biden's Chief of Staff Ron Klain **announced** that Biden will appoint a White House coronavirus response coordinator to lead his administration's pandemic strategy. The coordinator will also have a COVID-19 response team that will help manage vaccine distribution, oversee supply chain logistics, and work to improve access to testing.

### *Administration*

#### DEPARTMENT OF HEALTH AND HUMAN SERVICES

- To maximize access to COVID-19 vaccines for all Americans, HHS **announced** the U.S. government’s partnerships with large chain pharmacies and networks that represent independent pharmacies and regional chains. Through the partnership with pharmacy chains, this program covers approximately 60% of pharmacies throughout the 50 states, the District of Columbia, Puerto Rico, and the U.S. Virgin Islands. Through the partnerships with network administrators, independent pharmacies and regional chains will also be part of the federal pharmacy program, further increasing access to vaccine across the country—particularly in traditionally underserved areas.

#### DEPARTMENT OF LABOR

- Since the start of the coronavirus pandemic through Nov. 5, 2020, DOL's Occupational Safety and Health Administration (OSHA) has issued **204 citations** arising from inspections for violations relating to coronavirus, resulting in proposed penalties totaling \$2,856,533.
