WHAT HAPPENED TODAY

In an interview with CNBC, HHS Secretary Azar indicated we could have enough vaccines from Pfizer and Moderna to inoculate **20 million people** by the end of the year, adding that both vaccines require two shots to be effective.

Meanwhile, NIAID Director Dr. Fauci expressed concern about the growing vaccine hesitancy and anti-vaccine movement in the U.S., noting that unless an "overwhelming majority" of Americans get vaccinated, the risk of infection will remain high. Dr. Fauci acknowledged this will be a difficult undertaking that will require transparency and getting "public health issues out of the realm of political divisiveness."

Additionally, Federal Reserve Chairman Jerome Powell warned the rise in COVID-19 infection rates poses a threat to the economy. Despite recent positive vaccine advancements, Chairman Powell stated there are still "significant challenges and uncertainties" in the near term. He added a major concern is that people will "lose confidence" in the

- Senator Gary Peters (D-MI), Ranking Member of the Homeland Security and Governmental Affairs Committee, raised **concerns** that continued delays to the Presidential transition could interfere with the incoming Biden Administration's efforts to effectively distribute potential Coronavirus vaccines once authorized or approved.

FOOD AND DRUG ADMINISTRATION
