



## DAILY COVID-19 UPDATE

November 19, 2020

### WHAT HAPPENED TODAY

Today, the White House Coronavirus Task Force **held its first press briefing** in months as infections surge across the country. During the briefing, Vice President Mike Pence highlighted ongoing efforts and progress in combating the pandemic by preparations for speedy vaccine distribution and new therapeutics that have reduced the mortality rate of the virus. Vice President Pence announced the day after federal approval of a vaccine it will be available to states, and “a day after that we will begin” vaccinations for the “most vulnerable” and health care workers. Additionally, he reiterated the Trump Administration does not support another national lockdown or school closures.

Previously, other federal officials have also **expressed confidence** that every state will have access to at least some doses of a COVID-19 vaccine for distribution within 24-hours after federal authorization of the new drugs. General Gustavo Perna, chief operating officer for Operation Warp Speed, stated every jurisdiction will have “access immediately upon the initial push of the vaccine” with

weekly replenishments to cities, counties and states as more doses become available.

Additionally, the Centers for Disease Control and Prevention (CDC) held a rare media briefing today to [caution against traveling](#) for Thanksgiving. COVID-19 incident manager at the CDC Henry Walke cited an “exponential growth in cases” and the “opportunity to translocate disease or infection from one part of the country to another” as reasons the CDC is recommending people avoid traveling around the holiday.

## ECONOMIC UPDATE

### *Congressional*

#### HOUSE

- House Financial Services Chairwoman Maxine Waters (D-CA) [warned](#) that small businesses may permanently close due to COVID-19 if additional relief is not passed soon.

#### SENATE

- In a [floor speech](#), Senate Banking Committee Ranking Member Sherrod Brown (D-OH) urged Congress to work on passing additional COVID-19 relief.

### *Administration*

#### TREASURY

- The Treasury and IRS [released guidance](#) clarifying the tax treatment of expenses where a Paycheck Protection Program (PPP) loan has not been forgiven by the end of the year the loan was received.

#### INTERNAL REVENUE SERVICE (IRS)

- The IRS **reminded** people who don't normally file tax returns that November 21 is the deadline to register for an Economic Impact Payment.

### *Congressional*

#### HOUSE

- House Majority Leader Steny Hoyer (D-MD) released a **statement** following reports that coronavirus deaths in the U.S. have surpassed 250,000.

### *Administration*

#### DEPARTMENT OF HEALTH AND HUMAN SERVICES

- HHS announced the **launch** of a pilot program with five states to use rapid, portable, cartridge-based COVID-19 molecular test kits. The program will assess the integration of diagnostic tech into disease surveillance and infection control for nursing homes and other facilities.

#### DEPARTMENT OF DEFENSE

- During a recent **press conference**, a panel of Operation Warp Speed officials emphasized their optimism for both vaccine candidates from pharmaceutical companies Pfizer and Moderna, emphasizing they are "safe and effective."
