WHAT HAPPENED TODAY

Today, Speaker Nancy Pelosi (D-CA) announced that the tone of the stimulus negotiations have been "indicative of the decision to get the job done," as stalled stimulus talks gained momentum this week after a \$908 billion bipartisan, bicameral proposal was released.

Senate Majority Leader Mitch McConnell (R-KY) and Speaker Pelosi agreed yesterday that a COVID-19 stimulus bill and legislation to fund the government past December 11 should be combined for purposes of expediency.

Meanwhile, Senate Republicans such as Lindsey Graham (R-SC), Bill Cassidy (R-LA), and others are urging Leader McConnell to agree to a coronavirus relief package that has a price tag greater than \$500 billion.

During an interview with CNN, President-elect Joe Biden indicated that he will ask all Americans to wear masks for the first 100 days of his administration and also issue an order requiring masks in all federal buildings and on interstate transportation.
