



## DAILY COVID-19 UPDATE

December 15, 2020

### WHAT HAPPENED TODAY

Today, Treasury Secretary Mnuchin, Senate Majority Leader McConnell (R-KY), Senate Democratic Leader Schumer (D-NY), and House Minority Leader McCarthy (R-CA) were expected to meet with Speaker Pelosi (D-CA) and other congressional leaders at 4 p.m. to discuss a coronavirus relief package as well as an omnibus funding deal.

Leader McConnell stated yesterday, "We're not leaving here without a COVID package. We're going to stay here, no matter how long it takes."

He reiterated that lawmakers should move forward with a bipartisan bill "on what we can agree on."

Leader McConnell also added that the Biden Administration will likely ask for another package, so there will be "another opportunity to debate the merits of liability reform and state and local government in the very near future."

Notably, Senate Minority Whip Dick Durbin (D-IL), one of the members who introduced the \$908 billion bipartisan proposal, stated he would support moving forward with the \$748 billion package. He cited the

need to provide "emergency relief for the American people before we go home for the holidays."

Meanwhile, at a White House briefing earlier in the day, Press Secretary Kayleigh McEnany indicated that President Trump will "wait to see what the [stimulus] deal looks like" before committing to sign it.

Additionally, the Food and Drug Administration's (FDA) Vaccines and Related Biological Products Advisory Committee (VRBPAC) is slated to [meet](#) this Thursday to consider whether to grant emergency use authorization (EUA) to [Moderna](#) for their COVID-19 vaccine candidate. Following the vote, the decision will move to the FDA. The agency intends to issue an EUA for the vaccine on Friday.

## *Administration*

### FOOD AND DRUG ADMINISTRATION

- The FDA [issued](#) an emergency use authorization (EUA) for the first over-the-counter (OTC) fully at-home diagnostic test for COVID-19. The [Ellume COVID-19 Home Test](#) is a rapid, lateral flow antigen test, a type of test that runs a liquid sample along a surface with reactive molecules. The test detects fragments of proteins of the SARS-CoV-2 virus from a nasal swab sample from any individual 2 years of age or older.
- The FDA [released](#) a briefing document on Moderna's COVID-19 vaccine candidate.
- The FDA posted the [review memorandum](#) outlining the basis of the agency's decision to authorize the Pfizer-BioNTech COVID-19 Vaccine.
- As of December 14, 299 tests and sample collection devices are authorized by FDA under EUAs; these include 230 molecular tests and sample collection devices, 61 antibody tests, and 8 antigen tests.
