



## DAILY COVID-19 UPDATE

September 15, 2020

### WHAT HAPPENED TODAY

Today, the House Problem Solvers Caucus released a \$1.5 trillion coronavirus relief plan. The **'March to Common Ground' framework** includes, among other things, a second round of stimulus checks, boosted unemployment benefits, funding for COVID-19 testing and contact tracing, funding for state and local governments, and additional money for small business loans.

House Majority Leader Steny Hoyer (D-MD) rejected the package, saying it is smaller "than would be a responsible deal." At the same time, eight Democratic committee chairs noted the proposal "falls short of what is needed to save lives and boost the economy." The plan is also likely to meet sharp resistance from the White House and Senate Republicans due to the price tag. In comparison, Senate Majority Leader Mitch McConnell's (R-KY) **targeted relief package** is estimated to cost around \$650 billion.

#### HOUSE:

- House Ways and Means Ranking Member Kevin Brady (R-TX) [delivered remarks](#) during a press conference regarding House Republicans fall agenda.
- The House Small Business Committee [passed four bipartisan bills](#) to improve the Small Business Administration (SBA) Microloan program, increase small business exporting opportunities, and expand federal small business initiatives.

## **PUBLIC HEALTH UPDATE**

### ***Congressional***

#### **HOUSE**

- Reps. Pallone (D-NJ) and DeGette (D-CO) sent a letter to HHS Secretary Azar regarding reports that political appointees at the department are trying to influence scientific articles published by the CDC.
- Seven Democratic lawmakers sent a letter to HHS Secretary Azar and CDC Director Redfield regarding reports that political appointees trying to influence published scientific articles.
- Reps. Cárdenas (D-CA) and Watson Coleman (D-NJ) introduced the **COVID-19 Health Disparities Action Act**, which would require targeted testing, contact tracing, public awareness campaigns, and outreach efforts specifically directed at racial and ethnic minority communities and other populations that have been made vulnerable to the COVID-19 pandemic.

#### **SENATE**

- Sen. Hawley (R-MO) sent a letter to HHS Secretary Azar regarding utilizing CARES Act resources to curb drug abuse and mental health disorders.
- Sen. Durbin (D-IL) sent a letter to HHS Secretary Azar regarding COVID testing capacity challenges for schools, colleges and universities.

## ***Administration***

### **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

- HHS, through the Health Resources and Services Administration (HRSA), awarded approximately \$25 million to 80 award recipients across 36 states and two territories as part of the Rural Communities Opioid Response Program (RCORP).

### **CENTERS FOR MEDICARE & MEDICAID SERVICES**

- CMS issued [guidance](#) to state Medicaid directors designed to advance the adoption of value-based care strategies across their healthcare systems and align provider incentives across payers. Value-based care may also help ensure that the nation's healthcare system is better prepared and equipped to handle unexpected challenges, including the ongoing COVID-19 pandemic.

## NATIONAL INSTITUTES OF HEALTH

- NIH Director Dr. Francis Collins published a [blog post](#) titled, "Months After Recovery, COVID-19 Survivors Often Have Persistent Lung Trouble."
- NIH [awarded](#) seven contracts to companies and academic institutions to develop digital health solutions that help address the COVID-19 pandemic. The work could lead to user-friendly tools such as smartphone apps, wearable devices, and software that can identify and trace contacts of infected individuals, keep track of verified COVID-19 test results, and monitor the health status of infected and potentially infected individuals.

## FOOD AND DRUG ADMINISTRATION

- FDA [awarded](#) a new research contract to the University of Liverpool and global partners to sequence and analyze samples from humans and animals to create profiles of various coronaviruses, including SARS-CoV-2, which causes COVID-19. The study will also examine in vitro coronavirus models, such as organs-on-chips.
