## DAILY COVID-19 UPDATE

January 6, 2021

### WHAT HAPPENED TODAY

First and foremost, today was an unprecedented day in Washington with the events in and around the U.S. Capitol. That said, we did want to send out the Daily COVID-19 Update given that there were a number of developments today. We hope everyone is staying safe.

Despite a slow nationwide rollout of COVID-19 vaccines, NIAID Director Dr. Anthony Fauci expressed optimism yesterday that the U.S. could soon begin giving out at least [1 million doses per day](#). He noted that it's "very possible" President-elect Joe Biden will fulfill his promise to administer 100 million vaccines within his first 100 days in office. Dr. Fauci added that 70% to 85% of Americans must be vaccinated in order to achieve herd immunity, a goal he hopes to reach by September.

Additionally, Senate Minority Leader Chuck Schumer (D-NY) joined other Democratic leaders in support of \$2,000 stimulus checks. He noted an increase in economic impact payments will be the first priority for the Senate if Democrats gain control of the chamber.

#### FEDERAL RESERVE ("FED")

- The Federal Reserve Board and the Federal Open Market Committee [released the attached minutes](#) of the Committee meeting held on December 15 to 16, 2020.

#### INTERNAL REVENUE SERVICE (IRS)

- The Treasury Department and the Internal Revenue Service [issued guidance today](#) allowing deductions for the payments of eligible expenses when such payments would result in the forgiveness of a loan under the Paycheck Protection Program (PPP).

## PUBLIC HEALTH UPDATE

## Congressional

### HOUSE

- Rep. Velazquez [unveiled](#) the COVID-19 Prevention and Awareness Act, a bill that would allocate \$2.12 billion in funding for grants to help community health centers prevent and address the pandemic for New Yorkers who have underlying health conditions, and are therefore more susceptible to the coronavirus.

### SENATE

- Sen. Tina Smith (D-MN) sent a [letter](#) to President-elect Biden and Vice President-elect Harris about the persistent COVID-19 testing challenges and outlined a plan to ensure testing is free and widely available for all Americans.

## Administration

### FOOD AND DRUG ADMINISTRATION

- The FDA [posted](#) a new webpage on the CARES Act highlighting authorities that are intended to enhance the FDA's ability to identify, prevent, and mitigate possible drug shortages by, among other things, enhancing the FDA's visibility into drug supply chains.
- The FDA [released](#) a new episode of its podcast, FDA Insight. In this episode, Gail Bormel from the Office of Compliance in the FDA's Center for Drug Evaluation and Research joins Deputy Commissioner for Medical and Scientific Affairs Anand Shah, M.D. for a discussion on drug compounding and its contribution to fighting COVID-19.
- The FDA [issued](#) a safety communication titled, "Risk of False Results with the Curative SARS-CoV-2 Test for COVID-19."
- As of today, 310 tests and sample collection devices are authorized by the FDA under emergency use authorizations (EUAs). These include 235 molecular tests and sample collection devices, 64 antibody tests, and 11 antigen tests. There are 32 molecular authorizations that can be used with home-collected samples. There is one molecular prescription at-home test, one antigen prescription at-home test, and one over-the-counter (OTC) at-home antigen test.
