WHAT HAPPENED TODAY

Today, the Small Business Administration (SBA), in consultation with the Treasury, re-opened the Paycheck Protection Program (PPP) loan portal to provide additional support to small businesses who have been negatively impacted by the COVID-19 pandemic. Notably, SBA initially dedicated exclusive access to the portal for community financial institutions (CFIs), in an effort to better serve minority, underserved, and veteran and women-owned small businesses.

President-elect Joe Biden plans to unveil his COVID-19 relief plan on Thursday. He has stated the legislation will cost "trillions of dollars," and will include aid for state and local governments, among other items. Even though exact details of the package have yet to be released, a high price tag and funding for state and local governments were major sticking points for Republicans during previous negotiations, making the fate of the upcoming proposal unclear.
