WHAT HAPPENED TODAY

Yesterday, President-elect Joe Biden outlined his \$1.9 trillion coronavirus relief proposal. \$400 billion would be allotted to combat the pandemic, and the remaining \$1.5 trillion would be designated for state and local aid as well as economic relief. Among other things, Biden's legislative proposal, the [American Rescue Plan](#), includes \$1400 direct payments, \$50 billion to expand testing, \$130 billion to help schools reopen, boosted unemployment benefits through September at \$400 per week, \$25 billion in rental assistance, and temporary increase in tax credits for low-and middle-income families.

Senator Pat Toomey (R-PA), incoming Senate Banking Committee Ranking Member, [criticized](#) President-elect Biden's plan, calling it a "colossal waste and economically harmful." He pointed to the nearly \$3.4 trillion Congress authorized in COVID-related aid in 2020 as a reason additional fiscal support would be harmful. Sen. Toomey's early criticism and the package's trillion dollar price tag could indicate significant opposition from Republican lawmakers.

This afternoon, President-elect Biden is expected to announce a [plan](#) to vaccinate more Americans, with a particular focus on addressing vaccine misinformation and mistrust and making vaccines more accessible to low-income communities of color. He is also expected to unveil a \$1 billion national ad campaign to increase awareness and encourage Americans to get vaccinated.

Notably, President-elect Biden has [appointed](#) former FDA Commissioner [Dr. David Kessler](#) to lead Operation Warp Speed, replacing former pharmaceutical executive Moncef Slaoui. Dr. Kessler's role will focus primarily on maximizing the supply of COVID-19 vaccines that are authorized or approved and work with manufacturers to get more vaccines online.
