WHAT HAPPENED TODAY

Today, the Biden administration [announced](#) that the U.S. will increase its weekly supply of COVID-19 vaccines to states by an additional 5%, providing at least 10.5 million doses for the next three weeks. This comes on the heels of a recent announcement from the White House that it would increase vaccine supply to states by 16%. Also, on February 11, the federal government will begin delivering COVID-19 vaccines directly to select pharmacies to expand access nationwide. Furthermore, President Joe Biden [directed](#) FEMA to retroactively reimburse states for the cost of FEMA-eligible services "including masks, gloves, emergency feeding actions, sheltering at risk populations, and mobilization of the National Guard -- back dated to the beginning of the pandemic in January 2020."

Additionally, Senate Majority Leader Chuck Schumer (D-NY) announced that the chamber will hold a procedural vote today on a budget resolution with reconciliation instructions, which would allow Senate Democrats to pass portions of President Biden's \$1.9 trillion coronavirus relief package with just 51 votes.

Leader Schumer and Speaker Nancy Pelosi (D-CA) introduced the budget resolution last night.

The White House and Democratic leaders appear to be gaining momentum for their relief bill after the introduction of the budget resolution and President Biden's meeting with GOP senators, as Senator Joe Manchin (D-WV), a centrist swing vote, announced today he will vote to advance the Democratic budget resolution. However, he was clear his vote is predicated on the package focusing on "the COVID-19 crisis and Americans who have been most impacted by this pandemic."

Yesterday, President Biden and Vice President Kamala Harris met with a group of 10 Republican senators for more than two hours to discuss their \$618 billion COVID-19 relief proposal. In a joint statement, the senators described the meeting as "excellent" with "a very productive exchange of views." However, the White House issued a statement noting that President Biden had emphasized to the group that Congress "must respond boldly and urgently," while highlighting "many areas of disagreement with the Republicans." He also reiterated that he will not agree to a package that "leaves the nation short of its pressing needs." In the interim, the two sides have agreed to have their respective aides continue to negotiate a bipartisan relief plan.

Notably, the Biden administration purchased 8.5 million at-home COVID-19 tests from Ellume USA for \$231.8 million. According to the FDA, the tests are likely to cost \$30 each and provide results to your smartphone in 15 minutes with 95% accuracy. Production is expected to ramp up throughout the year until it reaches 640,000 home tests per day by December 2021.

Congressional

SENATE

- Senator Dick Durbin (D-IL) and Rep. Cindy Axne (D-IA) introduced a bill aimed at providing tax relief to people who received unemployment benefits last year amid the coronavirus pandemic.

- Senator Jack Reed (D-RI), along with over 45 other Senators, sent a letter to Senate Majority Leader Chuck Schumer (D-NY) and Minority Leader Mitch McConnell (R-KY) calling for inclusion of funding for the Low Income Home Energy Assistance Program (LIHEAP) in the next COVID-19 relief package.

- Treasury released its economic statement for the Treasury Borrowing Advisory Committee of the Securities Industry and Financial Markets.

SPECIAL INSPECTOR GENERAL FOR PANDEMIC RECOVERY (SIGPR)

- In the Special Inspector General for Pandemic Recovery's quarterly report to Congress, the federal oversight office announced it will probe former Treasury Secretary Steven Mnuchin on his decision to roll back the Federal Reserve's emergency lending facilities at the end of 2020.

PUBLIC HEALTH UPDATE

Congressional

SENATE

- Sen. Elizabeth Warren (D-MA) and Rep. Jan Schakowsky (D-IL) introduced the *Pandemic Emergency Manufacturing Act of 2021* to publicly manufacture personal protective equipment, prescription drugs, and other medical supplies necessary to combat the COVID-19 pandemic. The legislation authorizes the federal government to manufacture medical products, including by contracting with existing manufacturers, to ensure the nation has an adequate supply of critical materials to avoid rationing during this unprecedented crisis.
- Sen. Elizabeth Warren (D-MA) and Reps. Ayanna Pressley (D-MA) and Rep. Barbara Lee (D-CA) reintroduced the *Anti-Racism in Public Health Act*, a bicameral bill to declare structural racism a public health crisis and confront its public health impacts through two bold new programs within the CDC.
- Sens. Catherine Cortez Masto (D-NV) and Bill Cassidy (R-LA) introduced legislation to reimburse ambulance providers for services delivered to Medicare beneficiaries during the coronavirus pandemic.
