



## DAILY COVID-19 UPDATE

February 5, 2021

### WHAT HAPPENED TODAY

Today, the 56-member House Problem Solvers Caucus called for an immediate vote on a \$160 billion package to advance vaccine deployment and testing nationwide while the broader bipartisan talks and budget reconciliation process continue.

The "**Defeating COVID-19**" package includes \$50 billion to expand testing, \$35 billion for the provider relief fund with 20% set aside for rural hospitals, \$30 billion for the Disaster Relief Fund, \$20 billion for the National Vaccine Program, \$15 billion for the National Strategic Stockpile, and \$5 billion each for Title III of the Defense Production Act as well as PPE for first responders, physicians, and dentists.

In the early hours of this morning, the Senate adopted the budget resolution with Vice President Harris providing the tie-breaking vote. The House adopted the measure by a vote of 219 to 209 this afternoon. House and Senate committees will now have until February 16 to write the legislative language for COVID-19 relief bill under the approved budget instructions.

Speaker Nancy Pelosi (D-CA) and Majority Leader Steny Hoyer (D-MD) both told reporters that they anticipate the House will vote on a stimulus package and send it to the Senate during the week of February 22. Speaker Pelosi added the relief bill will "absolutely without any question" be enacted into law by March 15, which is when boosted unemployment benefits are set to expire.

Additionally, President Joe Biden appeared to signal today that he could push for passage of his \$1.9 trillion COVID-19 relief package without Republican support. He stated, "If I have to choose between getting help right now to Americans who are hurting so badly and getting bogged down in a lengthy negotiation...that's an easy choice...I'm going to act fast."

Notably, Johnson & Johnson has [submitted](#) its application to the FDA for an emergency use authorization of its one-dose COVID-19 vaccine.

## PUBLIC HEALTH UPDATE

### *Congressional*

#### HOUSE

- Reps. Ami Bera (D-CA) and Scott Peters (D-CA), and Sen. Tammy Baldwin (D-WI) introduced [legislation](#) to dramatically scale up the U.S. capacity to detect and respond to coronavirus variants. The *Tracking COVID-19 Variants Act* would provide \$2 billion for the CDC to support a robust, national sequence-based surveillance program that is vital to protecting public health and combatting the next phase of the COVID-19 pandemic, while preparing for emerging threats.

#### SENATE

- Sen. Edward Markey (D-MA) reintroduced [legislation](#) to support comprehensive research for the creation of a universal coronavirus vaccine or therapeutic. The legislation calls for a total investment of \$1 billion – \$250 million for each of FY 2021 through 2024 for NIAID.

#### FOOD AND DRUG ADMINISTRATION

- FDA Acting Administrator Dr. Janet Woodcock [issued](#) a statement indicating the agency continues to work with medical product sponsors and international partners to evaluate the impact each identified and emerging COVID-19 variant circulating globally as on effectiveness or utility of authorized medical products.
