## DAILY COVID-19 UPDATE

### WHAT HAPPENED TODAY

Today, the House Budget Committee announced it will markup the American Rescue Plan Act of 2021, the \$1.9 trillion coronavirus relief package, on Monday, February 22. The panel's press release stated it will combine all the committees of jurisdiction's provisions into a single measure "without substantive changes."

While the House is in the final stages of bringing its complete budget resolution to the floor, Republican lawmakers are pointing to unused, already allocated COVID-relief funds as a reason to scale back the almost \$2 trillion package. House Budget Committee Ranking Member Jason Smith (R-MO) stated there is "approximately \$1 trillion in existing COVID-19 funding" that has not been spent yet. He called for a "thorough and accurate accounting" of the remaining funds before Congress passes additional stimulus.

However, President Joe Biden has remained firm on his intent to "go big" on additional relief. He reiterated this week that "now is the time [Congress and the Administration] should be spending" to grow the economy, in the short- and long-term.

#### SENATE

- Senate Banking Committee Chairman Sherrod Brown (D-OH), along with Senators Maggie Hassan (D-NH), Ron Wyden (D-OR), Jeanne Shaheen (D-NH), and Mark Warner (D-VA), [are calling](#) for the Department of Labor to revise its policy that has limited the ability of workers, whose hours have been reduced, from receiving unemployment benefits through the Pandemic Unemployment Assistance (PUA) program.
- Chairman Brown is working to [include a provision](#) that would provide financial assistance to save multiemployer pension plans in the upcoming COVID-19 relief package.
- Senator Shaheen, a member of the Senate Appropriations Committee, [reintroduced legislation](#) to create a \$75 billion Homeowner Assistance Fund to help protect struggling homeowners and communities by preventing avoidable foreclosures, evictions and utility shutoffs.
