February 19, 2021

WHAT HAPPENED TODAY

Today, Senate Majority Leader Chuck Schumer (D-NY) indicated that the chamber "is on track" to pass a \$1.9 trillion coronavirus relief package before enhanced unemployment benefits expire on March 14. The House is prepared to pass the relief measure and send it over to the Senate next week, which would give the chamber about two weeks to make any changes to the legislation.

House Minority Whip Steve Scalise (R-LA) circulated a note to House Republicans today, calling the Democrats' stimulus bill a "package of progressive priorities" that will "keep schools closed, bail out blue states, pay people not to work, and raise the minimum wage to \$15 an hour." He urged House Republicans to vote 'no' on the bill next week.

Additionally, Treasury Secretary Janet Yellen reiterated President Biden's calls for a large stimulus package, stating "the price of doing too little is much higher than the price of doing something big." She also addressed concerns that too much government spending could result in inflation. She noted the Federal Reserve has tools to address any potential

risk of inflation, but the "greater risk is having this pandemic take a permanent lifelong toll" on people's lives.

During remarks at a G-7 meeting, President Joe Biden announced that the U.S. is committing \$4 billion to COVAX, the World Health Organization's global initiative to scale up manufacturing and distribution of COVID-19 vaccines to low- and middle-income countries. This includes an initial contribution of \$2 billion that Congress appropriated in December, as well a pledge to release another \$2 billion over two years once other donors have made their contributions. The Biden Administration will not donate any of its COVID-19 vaccine doses to underdeveloped countries until the U.S. population is vaccinated.

Notably, Pfizer and BioNTech announced new data that shows their COVID-19 vaccine remains stable for two weeks when stored at temperatures between -13°F and -5°F, easily achieved by pharmaceutical freezers and refrigerators. The companies are asking the Food and Drug Administration to update its authorization of the vaccine from the previously stated storage temperature of -112°F and -76°F, which requires expensive and specialized freezers.
