WHAT HAPPENED TODAY

Today, Senate Majority Leader Chuck Schumer (D-NY) held a meeting with the Democratic Caucus during which he discussed the need to prioritize passage of the upcoming COVID-19 relief package. He told members that "job number one is to pass the bill" and expressed confidence this will occur.

Yesterday, the House Budget Committee voted 19-16 on a largely party-line vote to advance President Joe Biden's \$1.9 trillion coronavirus relief package. The legislation will now be marked up by the House Rules Committee before it is sent to the floor on Friday or Saturday for consideration by the full House.

However, the minimum wage increase currently included in the House's version of the legislation could be a sticking point for centrist Democrats such as Senators Joe Manchin (D-WV) and Krysten Sinema (D-AZ). Senator Manchin has stated he supports an \$11 an hour minimum wage increase, but the current proposal is set at \$15 an hour.

SENATE

- 75 members of Congress sent a [letter](#) to President Joe Biden expressing concern regarding Xavier Becerra's nomination for the position of HHS Secretary. Among other things, the lawmakers urged President Biden to

- "withdraw Mr. Becerra's nomination" and offer a "nominee equipped to successfully combat the COVID-19 pandemic and safely reopen our country."
- Sen. Chris Murphy (D-CT) sent a [letter](#) to the Biden administration's COVID-19 Taskforce to request that federal contracts to produce critical medical supplies include small and medium businesses.
- Sens. Rob Portman (R-OH) and Sheldon Whitehouse (D-RI) introduced [legislation](#) to support the expansion of telehealth services for substance use disorder treatment. The bill builds upon the Trump Administration's actions to waive regulatory restrictions for accessing care in the wake of the COVID-19 pandemic. The bill extends these telehealth flexibilities by making permanent key waivers, including the ability to prescribe Medication Assisted Therapies (MAT) and other necessary drugs without needing a prior in-person visit and the ability to bill Medicare for audio-only telehealth services.
