WHAT HAPPENED TODAY

Today, President Joe Biden and moderate Senate Democrats reached a deal to narrow eligibility for the economic impact payments. Hours before the Senate is expected to begin debate on the floor, Democrats and President Biden agreed to lower the earnings ceiling for the \$1,400 checks. The new income cap will be lowered to \$80,000 for individuals and \$160,000 for joint filers, down from \$100,000 and \$200,000, respectively.

Notably, President Biden and Senate Democrats agreed to keep boosted unemployment benefits at an additional \$400 per week, rather than lowering them to \$300 per week like some moderate Democrats proposed. Senate Minority Leader Mitch McConnell (R-KY) criticized the bill as "far, far out of proportion to what's needed now." He argued the continuation of supplemental unemployment benefits will "keep workers at home when we should be focusing on rehiring."

Yesterday, President Biden announced that the Administration expects to have a sufficient supply of COVID-19 vaccines to inoculate all Americans by the
