WHAT HAPPENED TODAY

Over the weekend, after a 25-hour debate and vote-a-rama, the Senate voted 50-49, along party lines, to pass the American Rescue Plan. The legislation includes, among other things, \$1400 in direct stimulus payments; \$350 billion in state and local aid; funding for COVID-19 vaccine distribution and testing; an extension of boosted unemployment benefits at \$300 per week through September 6; 100% subsidy for COBRA insurance coverage for unemployed Americans; incentives for states to expand Medicaid; an expansion of Affordable Care Act subsidies; \$7.5 billion for the Paycheck Protection Program; an elimination of the Medicaid drug rebate cap; and \$47.8 billion for implementation of a national evidence-based testing strategy.

The \$1.9 trillion coronavirus relief package is set to go back to the House for final approval as early as tomorrow before President Joe Biden signs it into law.

House progressives have expressed some frustration over the lowered unemployment benefits, reduced income thresholds for stimulus checks, and removal of the minimum wage increase. However,

FOOD AND DRUG ADMINISTRATION

- On Friday, the FDA issued an emergency use authorization (EUA) for the at-home [Cue COVID-19 test](#). The product is a molecular nucleic acid amplification test (NAAT) that is intended to detect genetic material from SARS-CoV-2 virus present in the nostrils. The test is the first molecular test authorized for at-home use without a prescription.
- On Friday, the FDA issued an EUA for the T-Detect COVID Test developed by Adaptive Biotechnologies. The [T-Detect COVID test](#) is a next generation sequencing based (NGS) test to aid in identifying individuals with an adaptive T cell immune response to SARS-CoV-2, indicating recent or prior COVID-19 infection.

NATIONAL INSTITUTES OF HEALTH

- NIH has launched the last of three [Phase 3 clinical trials](#) to evaluate the safety and effectiveness of blood thinners to prevent life-threatening blood clots in adults diagnosed with COVID-19. The first patient in the trial was enrolled on February 15.

CENTERS FOR DISEASE CONTROL AND PREVENTION

- CDC issued [guidance](#) on activities that fully vaccinated individuals can safely resume while continuing to protect themselves and others.
