



DAILY COVID-19 UPDATE

March 11, 2021

WHAT HAPPENED TODAY

Today, President Joe Biden signed the \$1.9 trillion coronavirus relief package, the American Rescue Plan, into law. During the signing, President Biden stated the "historic legislation is about rebuilding the backbone of this country." According to White House Press Secretary Jen Psaki, some individuals could begin receiving the \$1,400 direct stimulus payments as early as this weekend.

Additionally, President Biden is set to deliver his first [**primetime address**](#) at 8 p.m. ET tonight to commemorate the one-year anniversary since COVID-19 was officially declared a pandemic by the World Health Organization and the shutdown began.

Notably, House Small Business Committee Chairwoman Nydia Velázquez (D-NY) and Ranking Member Blaine Luetkemeyer (R-MO) [**reached a bipartisan agreement**](#) to extend the Paycheck Protection Program (PPP) for two months past the current March 31 termination date. The House is expected to vote on the legislation next week before lawmakers leave Washington for their spring recess through mid-April.
