WHAT HAPPENED TODAY

Today, President Joe Biden and Vice President Kamala Harris delivered remarks on the American Rescue Plan at a Rose Garden event. President Biden touted the passage of the relief bill, saying "It's going to make a difference in the lives of millions of people in concrete, specific ways."

In his first primetime address last night, President Biden directed states to expand COVID-19 vaccine eligibility to all adults by May 1, with a goal of returning to normalcy by the beginning of July. He also outlined the Administration's other priorities to ramp up vaccination including, among other things, an increase in the number of community health centers, pharmacies, and mass vaccination centers where Americans can get inoculated; an expansion of the types of professionals that can administer vaccines by making dentists, optometrists, veterinarians, midwives, paramedics, and others eligible; and plans for a federally supported website to be released by May 1 to help people find vaccine appointments.

LATEST STATISTICS

133,337,525 COVID-19 vaccines have been distributed in the U.S and **65,965,305** Americans have received the first dose.

There are a total of **118,867,662** confirmed cases worldwide, 2,634,979 deaths and 67,329,604 people have recovered.

There are **29,330,642** confirmed cases of the coronavirus in the U.S. and 532,151 deaths.

He added "it is unlikely we will eradicate" [COVID-19] because it is so widespread.
