WHAT HAPPENED TODAY

Today, President Joe Biden announced he has appointed Gene Sperling to lead implementation of the American Rescue Plan. President Biden stated the \$1.9 trillion legislation "requires fastidious oversight to make sure the relief arrives quickly, equitably and efficiently, with no waste or fraud," and Mr. Sperling is "ready to get to work" to accomplish this goal.

Mr. Sperling led the White House Economic Council under Presidents Bill Clinton and Barack Obama, and served as an informal advisor to President Biden during his presidential campaign. Mr. Sperling will coordinate with heads of White House policy councils and federal agencies in order to "get funds out the door quickly, maximize its impact, accelerate the work the administration is doing to crush COVID-19, and rescue our economy."

Additionally, the Biden Administration is launching the "Help is Here" tour to "communicate directly with Americans about how the Rescue Plan is helping them and their families." Tomorrow, President Biden will travel to Pennsylvania to "highlight how the
