March 19, 2021

WHAT HAPPENED TODAY

Today, the U.S. reached President Joe Biden's goal of administering 100 million COVID-19 vaccine doses -- 42 days ahead of the target date of his 100th day in office. With the nation now administering 2.5 million shots per day, President Biden signaled he will set a new goal next week, stating, "We may be able to double it."

Additionally, President Biden announced his intent to nominate Dawn O'Connell for the position of Assistant Secretary for Preparedness and Response (ASPR) at the Department of Health and Human Services (HHS). Ms. O'Connell currently serves as Senior Counselor to the Secretary for COVID-19. She most recently served as Director of the Coalition for Epidemic Preparedness Innovations and was the Senior Counselor and Deputy Chief of Staff to HHS Secretary Sylvia Burwell during the Obama Administration.

Notably, the Centers for Disease Control and Prevention (CDC) released relaxed social distancing guidance for schools, noting that students can maintain a separation of three feet instead of six

SENATE

- Sen. Marco Rubio (R-FL) introduced [legislation](#) to extend the covered period for the Paycheck Protection Program (S. 815), which is a Senate Republican version of the House-passed Paycheck Protection Program Extension Act.
- Senate Banking Committee Chairman Sherrod Brown (D-OH), along with Sens. Robert Menendez (D-NJ) and Chris Van Hollen (D-MD), [criticized](#) Senate Republicans for blocking their legislation to protect relief checks provided in the American Rescue Plan from garnishment by private debt collectors.

HOUSE

- House Small Business Committee Chairwoman Nydia M. Velázquez (D-NY) issued a [statement](#) after the Small Business Administration (SBA) announced the Shuttered Venue Operators Grant (SVOG) program would start accepting applications on April 8, 2021.

HOUSE

- Reps. Cathy McMorris Rodgers (R-WA), Brett Guthrie (R-KY), and Morgan Griffith (R-VA) sent a [letter](#) to NIH Director Dr. Francis Collins requesting an independent, scientific investigation into the origins of the COVID-19 pandemic.
- Rep. Buddy Carter (R-GA) reintroduced the State Strategic Stockpile Readiness Act, [legislation](#) that would establish a pilot program to award dollar-for-dollar federal matching grants to states to expand or maintain a strategic stockpile of commercially available drugs, medical equipment, personal protective equipment, and other medical products deemed essential in the event of a public health emergency.
- At a press conference earlier this week, Reps. Rosa DeLauro (D-CT), Jan Schakowsky (D-IL), Earl Blumenauer (D-OR), Lloyd Doggett (D-TX), Adriano Espaillat (D-NY), and Andy Levin (D-MI) [urged](#) President Biden to support an emergency temporary waiver of some Trade-Related Aspects of Intellectual Property Rights (TRIPS) rules so that greater supplies of vaccines, treatments, and diagnostic tests can be produced globally.
