



## DAILY COVID-19 UPDATE

March 22, 2021

### WHAT HAPPENED TODAY

Last Friday, the House passed [\*\*H.R. 1868\*\*](#), legislation to avert spending cuts that otherwise would be triggered by the American Rescue Plan as well as continue the moratorium on the 2% Medicare sequester, set to expire on March 31, through the end of the year. Without the legislation, the \$1.9 trillion package would trigger \$381 billion in cuts annually for the next five fiscal years under the Pay-As-You-Go Act of 2010 (PAYGO) rule, according to the Congressional Budget Office (CBO). House Budget Committee Chairman John Yarmuth (D-KY) stated the legislation is "needed to avert painful and indiscriminate cuts to Medicare, farm support, and other programs."

Additionally, Senate Majority Leader Chuck Schumer (D-NY) filed cloture on the PPP Extension Act of 2021 ([\*\*H.R. 1799\*\*](#)) and the chamber is expected to consider the bill this week before leaving for a two-week recess.

Over the weekend, NIAID Director Dr. Anthony Fauci warned that B.1.1.7, the COVID-19 variant first discovered in the U.K., may account for up to 30% of

new infections across the U.S. He also noted that this particular variant is 50% more transmissible and could result in a more severe infection than the original COVID-19 strain.

Notably, a phase 3 U.S. trial found that AstraZeneca's COVID-19 vaccine is safe and 79% effective in preventing symptomatic infection. The company plans to apply for emergency use authorization (EUA) from the Food and Drug Administration (FDA) in the first half of April.

- The Department of the Treasury, the Internal Revenue Service (IRS), and the Bureau of the Fiscal Service [announced](#) that the next batch of Economic Impact Payments will be issued to taxpayers this week.

#### FEDERAL RESERVE

- The Federal Reserve [released](#) the 2020 combined annual audited financial statements for Federal Reserve Banks, as well as statements for the 12 individual Federal Reserve Banks, the Board of Governors, and five limited liability companies that manage and operate some of the credit facilities established by the Board in response to the COVID-19 pandemic.

#### SMALL BUSINESS ADMINISTRATION (SBA)

#### THE WHITE HOUSE

- The FDA issued an [emergency use authorization](#) (EUA) for the first machine learning-based COVID-19 non-diagnostic screening device that identifies certain biomarkers that are indicative of certain types of conditions, such as hypercoagulation.
- Dr. Janet Woodcock, Acting Commissioner of Food and Drugs and Judy McMeekin, Pharm.
