### WHAT HAPPENED TODAY

Today, President Joe Biden [signed](#) the PPP Extension Act of 2021 (H.R. 1799) into law. The bill will extend the application deadline to May 31 and give the Small Business Administration additional time to process applications. The bill passed both the House and Senate in recent weeks with overwhelming bipartisan support.

Additionally, the leaders of 23 countries joined the World Health Organization to call for a [global pandemic treaty](#) that would prepare future generations for public health emergencies.

Notably, in a [survey](#) conducted by the People's Vaccine Alliance, nearly 33% of epidemiologists, infectious disease specialists, and virologists believe the COVID-19 vaccines will have an efficacy window of nine months or less. Furthermore, 88% of the experts said that persistent low vaccine coverage in many countries will make it more likely for resistant variants to appear.

### LATEST STATISTICS

**189,451,285** COVID-19 vaccines have been distributed in the U.S and **96,044,046** Americans have received the first dose.

There are a total of **127,987,404** confirmed cases worldwide, **2,796,994** deaths and **72,610,560** people have recovered.

There are **30,378,955** confirmed cases of the coronavirus in the U.S. and **550,688** deaths.

### *Congressional*

#### SENATE

- Senate Finance Committee Chairman Ron Wyden (D-OR), along with 20 other Senate Democrats, [urged](#) President Biden to include recurring direct payments to individuals and enhanced unemployment benefits for the duration of the COVID-19 pandemic in his Build Back Better plan.

### *Administration*

#### TREASURY

- Treasury and the IRS [announced](#) that Economic Impact Payments will begin to be issued this weekend to Social Security recipients and other federal beneficiaries who do not normally file a tax return.
- Deputy Treasury Secretary Wally Adeyemo [met virtually](#) with racial and economic justice leaders to discuss Treasury's commitment to equitable implementation of the American Rescue Plan.

#### SMALL BUSINESS ADMINISTRATION

- The Small Business Administration [revised](#) the Paycheck Protection Program (PPP) platform procedures for addressing hold codes on first draw PPP loans and compliance check error messages on first draw PPP loans and second draw PPP loans.
