WHAT HAPPENED TODAY

Today, NIAID Director Anthony Fauci responded to CDC Director Rochelle Walensky's comments earlier this week about "impending doom" over rising coronavirus cases. Dr. Fauci stated he would not have used Director Walensky's exact words, but noted "she's making a valid point." He added that the rise in cases after previously plateauing over the last couple weeks is concerning and cautioned against declaring "victory prematurely."

Pfizer and BioNTech announced today that recent trials suggest their COVID-19 vaccine offers protection against the virus for at least six months, and may also be effective against the coronavirus variant first found in South Africa. Previously, there had been concerns about vaccine efficacy because it has shown to be resistant to some COVID-19 therapeutics and vaccines.

Additionally, the Food and Drug Administration (FDA) authorized two rapid at-home COVID-19 tests late Wednesday night. The authorization of the tests will allow individuals to get results in 15 minutes or less

- Sens.
