

DAILY COVID-19 UPDATE

April 2, 2021

WHAT HAPPENED TODAY

Today, the Bureau of Labor Statistics reported the American economy added 916,000 jobs in March, lowering the unemployment rate to 6 percent. However, over 8 million jobs that existed a year ago have yet to return. Labor Secretary Marty Walsh **stated** the report shows "growth across most sectors of the economy indicating that recovery is building momentum," but "disparities within the workforce continue to be a major concern."

President Biden also lauded the jobs report for March, but he cautioned the "progress we've worked so hard to achieve can be reversed." President Biden touted his recently proposed American Jobs Plan as a way of "building back better -- for good." Secretary Walsh also stated President Biden's plan "offers a bold and necessary path to a sustainable and vibrant economy that is competitive and inclusive."

Notably, today the CDC **announced** fully vaccinated people can travel safely within the United States, and vaccinated travelers can forgo COVID-19 testing and do not have to self-quarantine before and after travel. However, the CDC still recommends fully vaccinated



FOOD AND DRUG ADMINISTRATION

- FDA **announced** two revisions regarding the number of doses per vial available for the Moderna COVID-19 Vaccine. The agency's decision allows Moderna to increase its doses per vial from 10 to 15, and allows vaccinators to extract 11 doses from the existing 10-dose vials depending on the availability of certain syringes.
