



## DAILY COVID-19 UPDATE

April 5, 2021

### WHAT HAPPENED TODAY

Today, Treasury Secretary Janet Yellen cautioned that if wealthier nations do not assist developing countries respond to the COVID-19 pandemic it will lead to a "deeper and longer-lasting crisis" that could harm the U.S. economy. Secretary Yellen stated that without more medical and economic aid, developing countries will experience "mounting problems of indebtedness, more entrenched poverty, and growing inequality."

Over the weekend, more than four million people in the U.S. received a coronavirus vaccine on Saturday -- the nation's highest one-day total. Andy Slavitt, a senior adviser on the White House coronavirus response team, announced that an average of 3.1 million shots have been administered over a seven-day period and almost 1 in 4 adults are now fully vaccinated.

Additionally, 12 more states have opened COVID-19 vaccination registrations to everyone over the age of 16, bringing the nationwide total to 33 states with lowered age restrictions. Delaware, New York, Maine, North Carolina, and Missouri are all expected to make
