April 14, 2021

WHAT HAPPENED TODAY

Today, the Advisory Committee on Immunization Practices (ACIP) held a three-hour emergency [meeting](#) to review clinical [data](#) on the six women who developed a rare blood-clotting disorder after receiving Johnson & Johnson's COVID-19 vaccine. The independent expert group will make a recommendation to the Centers for Disease Control and Prevention (CDC) and the Food and Drug Administration (FDA) about how, or whether, the Johnson & Johnson vaccine should be utilized going forward.

Additionally, Treasury [announced](#) the establishment of the Office of Recovery Programs to lead the department's implementation of economic relief and recovery programs, including the \$420 billion in programs from the American Rescue Plan Act of 2021. The Office of Recovery will oversee the State and Local Fiscal Recovery Fund, Emergency Rental Assistance, the Homeowner Assistance Fund, the State Small Business Credit Initiative, the Capital Projects fund, the Coronavirus Economic Relief for Transportation Services (CERTS) Program, the Payroll Support Program, the Coronavirus Relief Fund, and the Airline and National Security Loan

Yesterday evening, the House voted 384-38 to pass the Senate's amended version of [H.R. 1868](#), which would delay the 2% Medicare sequester payment cuts for the remainder of 2021. The bill now goes to President Joe Biden, who is expected to sign it into law.
