



DAILY COVID-19 UPDATE

WHAT HAPPENED TODAY

Today, the Biden Administration announced that it will allocate \$1.7 billion in funds from the American Rescue Plan to the Centers for Disease Control and Prevention, states, and jurisdictions to detect, monitor, and track COVID-19 variants. Specifically, \$1 billion will go towards the expansion of genomic sequencing, \$400 million to establish six Centers of Excellence in Genomic Epidemiology, and \$300 million to build and support a National Bioinformatics Infrastructure. An initial tranche of \$240 million will be disbursed to states and territories early next month.

The Biden Administration also announced that it is investing \$4 billion in Indian country to increase COVID-19 vaccinations and tests, medical supplies, therapeutics, personal protective equipment, contact tracing, and build vaccine confidence, among other things.

Additionally, Sens. Bernie Sanders (I-VT), Elizabeth Warren (D-MA), Tammy Baldwin (D-WI), and Sherrod Brown (D-OH) led six of their colleagues in a [letter](#) to President Joe Biden, calling on him to support a proposal from the Indian and South African

governments urging the World Trade Organization to temporarily waive intellectual property rules related to COVID-19 vaccines and treatments to allow for a scale up in manufacturing to benefit the poorest countries.

Yesterday, the Federal Communications Commission (FCC) **announced** that it will begin accepting applications for the second round of its COVID-19 telehealth program on April 29 at 12PM ET. This new round of funding will provide \$249.95 million to support healthcare providers and patients in all 50 states, the District of Columbia, and territories. Applications will be accepted until May 6 at 12PM ET.

Notably, executives of Pfizer and Moderna have indicated that annual boosters of the COVID-19 vaccine will be necessary to maintain protection against the virus as it evolves.

HOUSE

- Yesterday, the House **passed three bipartisan bills** to make reforms to critical Small Business Administration (SBA) lending programs.

SENATE

- Senators Angus King (I-ME) and Todd Young (R-IN), along with a bipartisan group of Senators, **sent a letter** to Treasury Secretary Janet Yellen urging the department to clearly communicate that state and local governments can designate mental health and substance use disorder services as acceptable use for American Rescue Plan funds.
- Senators Chris Coons (D-DE) and Roger Wicker (R-MS), along with 15 bipartisan Senators, **reintroduced** the Cultivating Opportunity and Recovery from the Pandemic through Service (CORP) Act to expand national service programs to help the country recover and rebuild from COVID-19.
